## STATEMENT

This statement is being made in the context of speculative news reports and articles that have been published pertaining to a personal matter of one of our directors, Mr. Ness Wadia.

The matter is purely personal to Mr. Wadia and the company sought clarifications from Mr. Wadia. The company does not involve itself with the personal litigation and affairs of its directors, employees and promoters.

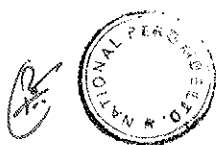
The Company is informed that its Director, Mr. Ness N. Wadia was detained on March 3, 2019 at Chitose Airport, Sapporo, Japan for alleged possession of Cannabis under the Cannabis Control Act and the Customs Act of Japan.

On April 22, 2019, Mr. Ness Wadia was given a suspended sentence of two years, which sentence is suspended for a period of five years.

Mr. Ness Wadia has since been available to the company and is performing his duties in accordance with his role.

We have also obtained clear legal opinion that there is no question of disqualification / vacation of the office of director under Indian law since the matter relates to a court outside the territory of India, and since the sentence has been suspended and is without effect.
