This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes holds equity shares of Teamlease Services Limited (the company), listed on your stock Exchange.

The Fund under its schemes has carried out sale of 54,279 shares of the Company on February 20, 2024. As a result, the shareholding of the Fund has decreased by 2.21% of the paid-up capital of the company as compared to previous disclosure on May 10, 2023 for 5.07%.
