Represents less than 25% of the total paid-up capital of the Company prior to Buyback as on March 31, 2018, in terms of equity shares of face value of Rs. 5/each. The proviso to Section 68(2)(c) of the Companies Act, 2013, as amended, and Regulation 4(i) of the Securities and Exchange Board of India (Buy-Back of Securities) Regulations, 2018 state that the buyback of equity shares in any financial year shall not exceed 25% of the total paid-up equity share capital of the Company in that financial year.
