









Revenue from Operations (₹ crore)



EBITDA (₹ crore)




Profit after Tax (₹ crore)








EBITDA Margin (%)




Debt-Equity Ratio (X)

Statement from the Chairman

I am pleased to write to you after another eventful year of progress. We are proud to have continued our industry-leading growth momentum through a year that was relentless with significant volatility and uncertainty owing to the ongoing war and supply chain constraints.

Our topline and bottomline numbers were at an all-time high. Business profitability improved a few notches higher. Our cash flow increased. In a nutshell, we made good progress. The growth resulted from some definitive steps in the right direction, which yielded heartening results.

We increased the strength of our sales team and widened our geographic presence. We introduced alluring schemes for our dealers and customers. We secured product approvals from large building contractors. These factors increased the flow of business opportunities.

FY23 was an important milestone from a product basket perspective. We introduced in-house developed and manufactured Stainless Steel Valves as a superior solution to imported brass valves. Since the product range is developed in-house, we could offer a wide range

In addition, we significantly widened our product range from 12-inch dia valves to 36-inch dia valves. This product expansion strengthens our presence in the oil & gas and petrochemical sectors, which are relatively uncluttered opportunity spaces.







Our product development efforts helped increase the proportion of value-added products in our revenue mix. Additionally, we sharpened our focus on reducing costs and enhancing process automation on the shopfloor – the combination of these factors helped improve business profitability.

Having elevated the organisation into a new growth orbit, the challenge lies in sustaining our momentum in the current year.

FY24 and onwards...

The current year will be exciting as Atam Valves is making an attractive diversification. We are adding a new vertical to our business—bathroom fittings.

For some time now, we have done our groundwork and market research, highlighting a yawning gap between the top-end international brands and the regional and local players. It is a space that serves our society's large and fast-growing middle and upper-middle sections but is relatively uncluttered.

Marketed under the 'Delle' brand, our bathroom fitting, currently outsourced, will cater to this market segment. We expect to commence operations of our manufacturing facility in FY24, after which we will manufacture all our products in-house and focus on widening our range to align with customer aspirations.

I am proud to state that the third generation of the promoter family, my grandson, is spearheading this vertical. I am confident that his expertise and energy will make this vertical a vital growth lever for the business over the coming years.

In our existing business, we will focus on manufacturing valves using special-grade inputs, which are in high demand in India and across the globe. This should help us grow our international business significantly over the coming years.

In closing....

Macro factors

India is progressing with passion and poise toward crossing the US\$ 5 trillion GDP mark.

India is all set to sustain its position as the fastest-growing major economy in the world, backed by the success of the Government's Production-Linked Incentive (PLI) Scheme.

The Scheme involves incentives of ₹1.97 lakh crore over five years and covers 13 sectors, such as telecom, electronics, auto parts, advanced batteries, pharmaceutical drugs, and solar energy components. It was also in tune with the Government's Aatmanirbhar Bharat campaign, as the PLI Scheme is expected to improve local manufacturing.

The PLI scheme is expected to bring in incremental investment of ₹7,920 crores, incremental production worth ₹1,68,000 crores, exports worth ₹64,400 crores, and earn direct and indirect revenues of ₹49,300 crores.









Gas: Currently, about 17,000 km of Natural Gas pipeline network is operational in the country. Moreover, there are plans to complete the National Gas Grid by developing additional 15,500 km (approx.) pipeline networks, which are at various stages of development. The goal is to achieve uniform economic and social progress across the country.

City Gas Distribution: City Gas Distribution (CGD) networks are a system of underground natural gas pipelines for supplying Piped Natural Gas (PNG) and Compressed Natural Gas (CNG) to domestic, commercial and industrial customers. The government estimates that about 50 million households will get PNG connections by 2030. Also, a target is set to increase the number of CNG stations to 10,000 by then. There's also a strong emphasis on the expansion of CGD networks across the country by covering 407 districts with the potential to make gas accessible to over 70% of the Indian population to enable the supply of cleaner cooking fuel to households,

industrial & commercial units as well as transportation fuel (such as CNG) to vehicles. An investment of ₹120,000 crore is envisaged towards this end over the next ten years.

Water infrastructure: India is also posed with the risk of a serious water crisis looming. The Jal Jeevan Mission launched by the Government of India in 2019 envisions providing safe and adequate piped drinking water to every rural household by 2024, and Rs.3.5 trillion has been allocated for this mission. The Government's Har Ghar Nal Se Jal programme announced in the Budget 2019-20 is an integral part of the Jal Jeevan Mission, and its goal is to implement sustainability measures such as greywater management, water conservation, and rainwater harvesting. In the 2023-24 budget, the Jal Jeevan Mission has again been prioritized, with the Government increasing its fund allocation by 15%. As of March 2023, India has invested US\$240 billion in the water sector through government resources and partnerships with private innovators.

Pharmaceuticals: Between FY18 and FY23, the Indian pharma industry witnessed an annual growth of 6-8%, owing to increased consumption in both domestic and foreign markets. But in 2023 alone, the Indian market grew by 5% to US\$ 49.78 billion with a modest export but robust domestic market growth. According to the CareEdge ratings, the Indian pharmaceutical industry is anticipated to grow at 7-8% in FY24-FY25, supported by a 6-7% growth in exports and an 8-9% growth in the domestic market during the same period.

Chemicals: The Indian chemicals industry is a significant player in the global market, ranking 6th in production and 14th in exports. The sector provides essential building blocks and raw materials for many industries, including agrochemicals, pharmaceuticals, textiles, paper, paints, and soaps. It is valued at US\$220 billion and projected to grow by approx. 9% p.a. during 2020-25 to reach US\$300 billion by FY 2025.

Management Discussion And Analysis Report

BACKGROUND

Our Company was originally incorporated as "Atam Valves Private Limited" on September, 30th, 1985 under the provisions of the Companies Act, 1956 vide Certificate of Incorporation issued by the Registrar of Companies, Punjab & Chandigarh. Later on, the company got converted into public limited company and the name of the company was changed to – "Atam Valves Limited" and fresh Certificate of Incorporation dated November 24th, 2017 was issued by the Registrar of the Companies, Punjab & Chandigarh.

Atam Valves Limited is one of the leading manufacturers of Valves, Cocks & Boiler Mountings in India. We are also an ISO 9001: 2008, ISO 14001: 2004, and CE Monogram and PED approved company & winner of National Award 2006 for quality and National Award 2009 for entrepreneurship Govt. of India.

Ever since inception in 1972, our brand names ATAM & FEBI emerged as formidable names in Bronze, Brass, Cast Iron, Cast Steel, Forged Steel, S.S. Valves & cocks, conforming to various National & International standards. We are pioneers in developing Ball Valves in India and enjoy a strong Brand image. ATAM VALVES are suitable for industrial and domestic applications as well as for controlling a wide variety of service fluids, Oil & steam, within various pressure & temperature ranges. "ATAM" products are approved by various quality institutions including bureau of Indian Standards. ECONOMY OVERVIEW

Global Economy

The global economy is facing a slowdown in 2023, after a modest recovery in 2022 from the pandemic-induced recession. The main factors that are weighing on the global growth prospects are:

 The ongoing war between Russia and Ukraine, which has disrupted the energy supply and trade in Europe and beyond. The conflict has also increased geopolitical tensions and uncertainty, affecting business confidence and investment.

- The inflationary pressures that have emerged from the surge in commodity prices, especially oil and gas, as well as the supply chain bottlenecks and labor shortages that have hampered production and distribution across various sectors.
- The policy tightening by some major central banks, such as the US Federal Reserve and the European Central Bank, which have started to raise interest rates and reduce their asset purchases in response to the rising inflation and growth expectations. This has led to higher borrowing costs and lower liquidity for businesses and consumers, especially in emerging markets that are more vulnerable to capital outflows and currency depreciation.
- The uneven vaccination progress and the emergence of new variants of the coronavirus, which have posed challenges for the public health and economic recovery in some regions, such as Africa and Latin America. The pandemic has also exacerbated social inequalities and poverty, as well as environmental issues.

The global economy is expected to grow by around 2% in 2023, down from 3.1% in 2022. The growth rate is below the pre-pandemic average of 3.5% and reflects the divergent performance of different regions and countries. Some of the highlights are:

- China is expected to lead the global growth with a rate of 5.5% in 2023, as it reopens its economy after a prolonged period of lockdowns and zero-covid policies. China's growth will be supported by its strong domestic demand, infrastructure spending, and export competitiveness.
- India is expected to grow by 7.8% in 2023, rebounding from a contraction of 7.3% in 2020. India's growth will be driven by its large population, favorable demographics, low interest rates, fiscal stimulus, and structural reforms.
- The US is expected to grow by 1.8% in 2023, slowing down from 5.6% in 2022. The US growth will be constrained by the fading effects of the fiscal stimulus, the monetary policy tightening, the supply chain disruptions, and the labor market challenges.
- The euro zone is expected to grow by 1.4% in 2023, decelerating from 4.6% in 2022. The euro zone growth will be hindered by the energy crisis, the political uncertainty, the fiscal consolidation, and the structural weaknesses.

 Japan is expected to grow by 0.8% in 2023, moderating from 2.7% in 2022. Japan's growth will be limited by its aging population, low productivity, high debt, and deflationary pressures.

The global economic outlook for 2023 is subject to significant risks and uncertainties, both on the upside and downside. Some of the potential scenarios that could affect the global economy are:

- A faster resolution of the Russia-Ukraine war, which could ease the energy supply constraints and improve the geopolitical stability.
- A stronger coordination of fiscal and monetary policies among major economies, which could boost the global demand and confidence.
- A further escalation of the Russia-Ukraine war, which could trigger a wider military conflict and a global oil shock.
- A sharper than expected tightening of monetary policies by major central banks, which could cause a financial market turmoil and a credit crunch.

Indian Economy

The Indian economy is expected to grow by 7% in FY 2023, recovering from a contraction of 7.3% in FY 2021 due to the impact of the covid-19 pandemic. The growth is supported by the easing of lockdowns, the acceleration of vaccination, the improvement of consumer and business confidence, and the stimulus measures by the government and the central bank.

The main sectors that are contributing to the growth are agriculture, industry, and services. Agriculture is estimated to grow by 3.9%, benefiting from a good monsoon and higher rural demand. Industry is estimated to grow by 9.6%, driven by manufacturing, construction, and mining, which have witnessed a revival of domestic and external demand. Services are estimated to grow by 8.4%, led by contact-intensive sectors such as trade, hotels, transport, and financial services, which have recovered as the pandemic situation improved.

The main challenges that the economy faces are inflation, fiscal deficit, external sector volatility, and structural reforms. Inflation has remained above the target range of 2-6% due to the rise in food and fuel prices. The central bank has raised its policy rate by 50 basis points to contain inflationary pressures. The fiscal deficit has widened to 6.8% of GDP due to lower revenue collection and higher expenditure on health, social welfare, and infrastructure. The external sector has been resilient with a current account surplus and high foreign exchange reserves, but faces risks from global uncertainties, currency appreciation, and trade deficit. The Company is also focused on increasing capacity utilization of all units, improving product-mix, reducing operating costs, launching new products and improving operational efficiency with technology upgradation.

During the year, based on the company's performance, the directors are also pleased to recommend for your consideration and approval for payment of final dividend of ₹1.5 /- per equity share of face value of ₹10/- each for the financial year 2022- 23. The final dividend on equity shares, if approved by the members would involve a cash outflow of ₹1,58,22,000/-. Pursuant to regulation 43A of the SEBI listing regulations, a dividend distribution policy is available on the company's website viz https://www.atamvalves.in.

SHARE CAPITAL

The paid up equity share capital as on March 31, 2023 stood at ₹10,54,80,000/- comprising of 1,05,48,000 shares of ₹10/- each fully paid shares. During the year under review, the company has increased its Authorised Capital from ₹5,00,00,000 to ₹6,50,00,000 in Extra- ordinary General Meeting held on 20.04.2022. The Company has allotted 23,49,000 Equity warrants optionally convertible into Equity Shares (the total Issue price per warrant is ₹52/- convertible into One Equity Share of the Company having face value of ₹10/- including a premium of ₹42/- per equity share) on 10.05.2022, out of which 18,00,000 Equity Warrants were allotted to Mr. Amit Jain, Promoter of the Company and rest 5,49,000 Equity Warrants were allotted to Non- Promoter/ Public Category of the Company.

On, 19.09.2022, 5,49,000 Equity Warrants allotted to Non-Promoter/ Public Category of the Company were converted into Equity Shares and on 30.09.2022, 6,00,000 (out of 18,00,000 Equity Warrants) allotted to Mr. Amit Jain, Promoter of the Company were converted into Equity Shares. The funds were utilised for the purpose stated in the objects and there was no deviation from the same. The company has again increased its Authorized Capital from ₹6.50 Crores to ₹15.00 Crores on 30.09.2022. The company has issued 52,74,000 Bonus Shares in the ratio of 1:1 on 29.10.2022.

As on March 31, 2023, the Company has Six Directors comprising of Three Executive Directors and Three Non-Executive Independent Directors. There are two women directors.

In accordance with the provisions of the Companies Act 2013 read with SEBI (LODR) Regulations, 2015, on the recommendation of Nomination and Remuneration, the board proposes the Appointment of Mr. Bhavik Jain as Wholetime Director, and Mr. Parminder Singh as Non Executive Independent Director on the Board of the Company in the ensuing AGM of the Company for approval of members.

In the opinion of the Board, Mr. Parminder Singh is a person of integrity, fulfils requisite conditions as per applicable laws and is independent of the management of the Company.

Retirement by Rotation

Ms. Pamila Jain (DIN: 01063136) retires by rotation and being eligible, offers herself for re-appointment.

A resolution seeking shareholders' approval for their appointment/re-appointment along with other required details forms part of the Notice.

Independent Directors

In terms of Section 149 of the Act and the SEBI Listing Regulations, Ms. Rajni Sharma, Mr. Ravi Bhushan Jain, Mr. Surinder Kumar Salwan are the Independent Directors of the Company as on date of this Report.

All Independent Directors of the Company have given declarations under Section 149(7) of the Act, that they meet the criteria of independence as laid down under Section149(6) of the Act and Regulation 16(1)(b) of the SEBI Listing Regulations. In terms of Regulation 25(8) of the Listing Regulations, the Independent Directors have confirmed that they are not aware of any circumstance or situation, which exists or may be reasonably anticipated, that could impair or impact their ability to discharge their duties with an objective independent judgement and without any external influence.

In the opinion of the Board, the Independent Directors possess the requisite expertise and experience and are persons of high integrity and repute. They fulfill the conditions specified in the

Report on the Audit of the Financial Statements

Opinion

Note 1 Corporate Information

Atam Valves Limited (hereinafter referred to as "the Company") is a public limited company domiciled in India and incorporated under the provisions of the Companies Act, 1956 and has its registered office at 1051, Industrial Area, Jalandhar, Punjab. The Company is listed on SME platform of Bombay Stock Exchange (BSE) and has initiated the process of migration of Equity Shares of the Company to Main Board Platform of Bombay Stock Exchange Limited (BSE) and simultaneously to the Main Board Platform of National Stock Exchange of India Limited (NSE) during the current year. The Company is engaged in the business of manufacturing of Valves and fittings, steam traps and strainers.

The financial statements were approved and authorized for issue by the Company's Board of Directors in the meeting held on May 11, 2023.

Note 2 Statement of Compliance with Ind AS and Basis of preparation and measurement

I. Statement of Compliance

The financial statements have been prepared in accordance with Indian Accounting Standards (hereinafter referred to as "Ind AS") notified under Section 133 of the Companies Act, 2013 (the Act) read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time and other relevant provisions of the Act.

The financial statements up to year ended March 31, 2022 were prepared in accordance with the accounting standards notified under section 133 of the Companies Act 2013, read together with paragraph 7 of the Companies (Accounts) Rules, 2014 as amended (hereinafter referred to as "Previous GAAP") and other relevant provisions of the Act. These financial statements are the first financial statements of the Company under Ind AS. The date of transition to Ind AS is April 1, 2021.

Refer note 51 for the details of first-time adoption exemptions availed by the Company and an explanation of how the transition from previous GAAP to Ind AS has affected the Company's financial position, financial performance and cash flows.

II. Basis of Preparation and Measurement

 The financial statements have been prepared on historical cost convention on accrual basis except for certain financial instruments (including derivative instruments) which are measured at fair value at the end of each reporting period as required under Ind AS.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Company takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/ or disclosure purposes in the financial statements is determined on such a basis, except for measurements that have some similarities to fair value but are not fair value, such as net realisable value in Ind AS 2.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2, or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.
- (ii) Accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy hitherto in use.
- (iii) The functional and presentation currency of the Company is Indian rupees (₹) and all values are rounded to the nearest lakhs and two decimals thereof, unless otherwise stated.

Note 3 Significant Accounting Policies, Significant Accounting Estimates, Judgements and Assumptions and Applicability of New and Revised Ind AS

I. Significant Accounting Policies

A. Revenue Recognition

(i) Sale of goods

Revenue from sale of goods is recognised as and when the company satisfies performance obligation by transfer of control of goods.

Generally control is transferred upon shipment of goods to the customer or when the goods is made available to the customer, provided transfer of title to the customer occurs and the company has not retained any significant risk of ownership or future obligations with respect to the goods shipped.

Revenue is measured at the amount of consideration which the company expects to be entitled in exchange for transferring promised goods to a customer as specified in the contract, after deduction of any trade discounts, volume rebates and any taxes or duties collected on behalf of the Government such as goods and services tax, etc. Consideration is generally due upon satisfaction of performance obligation and receivable is recognized when it becomes unconditional and only passage of time is required before the payment is due. No element of financing is deemed present as the sales are made with the short term credit period generally consistent with market practices.

If the Company receives consideration before transfer of goods to the customer, such amount is presented as a contract liability. The company does not adjust such liability for the effects of significant financing component if it is expected that the promised goods will be transferred to the customer within a period of one year. Contract liabilities are recognised as revenue when the Company satisfies performance obligation as per the contract.

(ii) Interest Income

Interest Income from financial assets is recognized when it is probable that economic benefits will flow to the company and amount of income can be measured reliably. Interest income is accrued on time basis, by reference to principal outstanding and at effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of financial asset to that asset's net carrying amount on initial recognition.

(iii) Insurance and other claims

Insurance and other claims are recognized when no significant uncertainty exists with regard to the amount to be realized and the ultimate collection thereof.

(iv) Other Income

Other income is recognized when no significant uncertainty exists with regard to the amount to be realized and the ultimate collection thereof.

B. Employee Benefits

(i) Short term Employee Benefits:

Employee benefits payable wholly within twelve months of receiving employee services are classified as short-term employee benefits. The amount of short term employee benefits are recognized as an expense on an undiscounted basis in the statement of profit and loss of the year in which the related service is rendered.

(ii) Post-Employment benefit plans

(a) Defined Contribution Plan:

Provident fund is a defined contribution scheme. The Company has no obligation, other than the contribution payable to the provident fund. The Company recognizes contribution payable to the provident fund scheme as an expense, when an employee renders the related service.

(b) Defined Benefit Plan:

Gratuity

The Company provides for gratuity, a defined benefit retirement plan covering eligible employees of the Company. The Gratuity Plan provides a lump-sum payment to vested employees at retirement, death, incapacitation or termination of employment, of an amount based on the respective employee's salary and the tenure of employment with the Company.

Liability with regard to the defined benefit plan is determined by actuarial valuation, performed by an independent actuary, at each balance sheet date using the projected unit credit method.

The Company recognizes the obligation of the defined benefit plan in its balance sheet as a liability. Remeasurements comprising of actuarial gains and losses, and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability) are recognised in Other Comprehensive Income which are not reclassified to profit or loss in subsequent periods. All other expenses related to defined benefit plan are recognised in employee benefits expense in the Statement of profit and loss.



C. Property, plant and equipment

Property, plant and equipment are stated at cost or deemed cost applied on transition to Ind AS, less accumulated depreciation and impairment loss, if any. The cost directly attributable to acquisition are capitalised until the property plant and equipment are ready for use as intended by the management.

The cost of an item of Property, plant and equipment comprises of: (i) Purchase price including import duties and non-refundable purchase taxes after deducting trade discounts and rebates. (ii) Any expenditure directly attributable for bringing an asset to the location and the working condition for its intended use and (iii) The initial estimate of the costs of dismantling and removing the item and restoring the site on which it is located, the obligation for which an entity incurs either when the item is acquired or as a consequence of having used the item during a particular period for purposes other than to produce inventories during that period.

Subsequent expenditures relating to property, plant and equipment is capitalized only when it is probable that future economic benefits associated with these will flow to the Company and the cost of the item can be measured reliably. Repairs and maintenance costs are recognized in net profit in the statement of profit and loss when incurred.

Property, Plant and Equipment which are significant to the total cost of that item of Property, Plant and Equipment and having different useful life are accounted separately.

Property, plant and equipment which are not ready for intended use at each balance sheet date are disclosed as "Capital work-in-progress" and advances paid towards the acquisition of Property, plant and equipment outstanding at each balance sheet date are classified as Capital advances under "Other non-current assets".

On transition to Ind AS, the Company has elected to continue with the carrying value of its property, plant and equipment recognised as at April 1, 2021 (transition date) measured as per the previous GAAP and use that carrying value as the deemed cost of the property, plant and equipment.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The cost/deemed cost and the related accumulated depreciation are eliminated from the financial statements upon disposal or retirement of the asset and any gain or loss arising thereon is determined as the difference between sale proceeds and the carrying amount of the asset and is recognised in the statement of profit and loss.

D. Intangible Assets

Intangible assets are stated at cost or deemed cost applied on transition to Ind AS, less accumulated amortization and impairment, if any. The cost of intangible asset comprises of its purchase price, net of recoverable taxes and any directly attributable cost of preparing the asset for its intended use.

Subsequent expenditure is capitalised only when it increases the future economic benefits embodied in the specific asset to which it relates. All other expenditure is recognised in statement of profit and loss as and when incurred.

On transition to Ind AS, the Company has elected to continue with the carrying value of its intangible assets recognised as at April 1, 2021 (transition date) measured as per the previous GAAP and use that carrying value as deemed cost of intangible assets.

An intangible asset is derecognised upon disposal or retirement of the asset. The cost/deemed cost and the related accumulated amortization are eliminated from the financial statements upon disposal or retirement of the asset and resultant gains or losses are recognized in the statement of Profit and Loss when the asset is derecognized.

E. Depreciation and amortization

Depreciation is provided on Property, plant and equipment on written down value method on the basis of useful lives of such assets specified in Schedule II to the Act.

Depreciation method, useful lives and residual values are reviewed periodically, including at each financial year end with the effect of any changes in estimate accounted for on a prospective basis.

Amortization

Intangible assets are amortized on straight line method over the estimated useful life. The amortization method, useful life and residual value are reviewed at each financial year end. The estimated useful life is based on number of factors including effect of obsolescence and other economic factors and is as under:

F. Inventories

Inventories are valued at cost or net realizable value, whichever is lower except production waste/scrap which is valued at net realizable value. The raw materials and other supplies held for use in the production are valued at net realisable value only if the finished products in which they are to be incorporated are expected to be sold below cost.

Net Realisable Value is the estimated selling price in ordinary course of business less estimated cost necessary to make the sales.

G. Borrowing Costs

Borrowing costs directly attributable to the acquisition or construction of qualifying assets i.e. the assets that necessarily takes a substantial period of time to get ready for its intended use are capitalized as part of the cost of the asset. All other borrowing costs are expensed in the period in which they occur. Borrowing costs consist of interest and other costs that the Company incurs in connection with the borrowing of funds.

H. Earnings per Share

Basic earnings per share are computed by dividing the profit for the period attributable to the equity shareholders of the company by the weighted average number of equity shares outstanding during the period.

For the purpose of calculating diluted earnings per share, the profit for the period attributable to the equity shareholders and the weighted average number of shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares, if any.

I. Income Taxes

Income tax expense comprises current tax and deferred tax.

Current tax is the tax payable/receivable on the taxable profit/loss for the year using the tax rates and tax laws that have been enacted or substantively enacted by the end of the reporting period and any adjustment to taxes in respect of previous years. Interest expenses and penalties, if any, related to income tax are included in finance cost and other expenses respectively. Interest Income, if any, related to income tax is included in other income.

Current tax assets and current tax liabilities are offset when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle the asset and the liability on a net basis.

Deferred tax is recognised in respect of temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purpose at the reporting date using tax rates and tax laws that have been enacted or substantively enacted by the balance sheet date and are expected to apply to taxable income in the years in which those temporary differences are expected to be recovered or settled. The effect of changes in tax rates on deferred tax assets and liabilities

is recognized as income or expense in the period that includes the enactment or the substantive enactment date

A deferred tax asset is recognized to the extent, it is probable that future taxable profit will be available against where the deductible temporary differences and tax losses can be utilized. The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilized. Unrecognized deferred tax assets are re-assessed at each reporting date and are recognized to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.

Deferred tax assets and deferred tax liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and the deferred tax assets and the deferred tax liabilities relate to income taxes levied by the same taxation authority.

Income tax expense is recognised in statement of Profit and Loss except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, as the case may be.

J. Government Grants

Government grants are not recognized until there is reasonable assurance that all attached conditions will be complied with and the grant will be received.

When the grants relates to an expense item, it is recognised in the Statement of profit and loss by way of reduction from the related cost, which the grants are intended to compensate, except where the related expense is not directly identifiable. In such cases, the grant is presented in the 'Other Income'.

Government grants that becomes receivable as compensation for expenses or losses already incurred or for the purpose of giving financial support to the Company with no related costs is recognised in the Statement of profit or loss of the period in which it becomes receivable under 'Other operating income'/'Other income' based on the nature of grant.

Government grants relating to the purchase of property, plant and equipment are deducted from its gross value and are recognised in profit or loss on a systematic over the expected useful lives of the related assets by way of reduced depreciation.



K. Foreign Currency translations

Transactions in foreign currency are initially recorded in the functional currency i.e. Indian Rupees using the exchange rate prevailing at the date of transactions.

Monetary items denominated in foreign currency are reported using the exchange rate prevailing at the end of reporting period. The exchange difference arising on the settlement or reporting of monetary items at rates different from rates at which these were initially recorded / reported in previous financial statements, are recognised in the statement of profit and loss in the period in which it arise.

Non-monetary items denominated in foreign currency and measured at historical cost are recorded at the exchange rate prevalent at the date of transaction, Non-monetary items that are measured in term of historical cost in foreign currency are not reinstated.

L. Leases

Company as a lessee

The Company's lease asset classes primarily consist of leases for land and buildings. The Company assesses whether a contract contains a lease, at inception of a contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. To assess whether a contract conveys the right to control the use of an identified asset, the Company assesses whether: (i) the contract involves the use of an identified asset (ii) the Company has substantially all of the economic benefits from use of the asset through the period of the lease and (iii) the Company has the right to direct the use of the asset.

At the date of commencement of the lease, the Company recognizes a right-of-use asset ("ROU") and a corresponding lease liability for all lease arrangements in which it is a lessee, except for leases with a term of twelve months or less (short-term leases) and leases for which underlying asset is of low value. For these short-term and leases for which underlying asset is of low value, the Company recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease.

The right-of-use assets are initially recognized at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or prior to the commencement date of the lease plus any initial direct costs less any lease incentives. They are subsequently measured at cost less accumulated depreciation and impairment losses.

Right-of-use assets are depreciated from the commencement date on a straight-line basis over the shorter of the lease term and useful life of the underlying asset. Right of use assets is evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. For the purpose of impairment testing, the recoverable amount (i.e. the higher of the fair value less cost to sell and the value-in-use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the Cash Generating Unit (CGU) to which the asset belongs.

The lease liability is initially measured at amortized cost at the present value of the future lease payments. The lease payments are discounted using the interest rate implicit in the lease or, if not readily determinable, using the lessee's incremental borrowing rate. Lease liabilities are remeasured with a corresponding adjustment to the related right of use asset if the Company changes its assessment if whether it will exercise an extension or a termination option.

Lease liabilities and Right of Use assets have been separately presented in the financial statements. Lease Payments and interest thereon have been classified as cash flows from financing activities in the Statement of Cash flows.

M. Financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

(i) Initial Recognition and measurement

The company recognises the financial assets and financial liabilities when it becomes party to the contractual provision of the instruments. All financial assets and liabilities are recognised at fair value on initial recognition except for trade receivables which are initially measured at transaction price. Transaction costs that are directly attributable to the acquisition of financial assets and or issue of financial liabilities that are not recognized at fair value through profit or loss, are added to or reduced from the fair value of the financial assets or financial liabilities, as appropriate. Transaction cost directly attributable to the acquisition of financial assets and financial liabilities recognized at fair value through Profit or Loss are recognised immediately in the Statement of Profit and Loss.

Transaction cost directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit and loss are recognised immediately in the statement of profit and loss.

(ii) Subsequent measurement

For the purposes of subsequent measurement, financial instruments are classified as follows:

Non-derivative financial instruments

(a) Financial assets carried at amortised cost

A financial asset is subsequently measured at amortised cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Interest income for such instruments is recognised in profit or loss using the effective interest rate (EIR) method, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's gross carrying amount.

The carrying amounts of financial assets that are subsequently measured at amortised cost are determined based on the effective interest method less any impairment losses.

(b) Financial assets at fair value through other comprehensive income

A financial asset is subsequently measured at fair value through other comprehensive income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Interest income for such instruments is recognised in profit or loss using the effective interest rate (EIR) method, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's gross carrying amount.

Fair value movements are recognised in the other comprehensive income (OCI) until the financial asset is derecognised. On de-recognition, cumulative gain or loss previously recognised in OCI is reclassified from the equity to the profit or loss.

(c) Financial assets at fair value through profit or loss

A financial asset is subsequently measured at fair value through profit or loss unless it is measured at amortised cost or at fair value through other comprehensive income. Such financial assets are measured at fair value with all changes in fair value recognised in the statement of profit and loss.

Dividend and interest income from such instruments is recognized in the statement of profit and loss, when the right to receive the payment is established.

Fair value changes on such assets are recognised in the statement of profit and loss.

(d) Financial liabilities

Financial liabilities are classified as at fair value through profit or loss when the financial liability is either contingent consideration recognised by the Company as an acquirer in a business combination to which Ind AS 103 applies or is held for trading or it is designated as at FVTPL.

All other financial liabilities are subsequently measured at amortized cost using the effective interest method unless at initial recognition, they are classified as measured at fair value through profit and loss.

Financial liabilities carried at fair value through profit or loss, are measured at fair value with all changes in fair value recognised in the statement of profit and loss.

Interest expense for the financial liabilities subsequently measured at amortized cost is recognised in profit or loss using the effective interest rate (EIR) method.

(e) Equity Instruments

An equity instrument is any contract that evidences a residual interest in the assets of the Company after deducting all of its liabilities. Equity instruments are recorded at the proceeds received. Incremental costs directly attributable to the issuance of equity instruments and buy back of equity instruments are recognized as a deduction from equity, net of any tax effects.

(iii) De-recognition of financial instrument

a) A financial asset (or, a part of a financial asset) is primarily derecognized when the contractual right to the cash flows from the financial asset expires, or the company transfers its right to receive cash flow from the financial assets and substantially all the risks and rewards of ownership of the asset to another party.

On de-recognition of a financial asset, the difference between the asset's carrying amount and the sum of the



consideration received/receivable is recognised in the profit or loss.

b) A financial liability (or a part of financial liability) is derecognized when obligation specified in the contract is discharged or cancelled or expires.

On de-recognition of a financial liability, the difference between the carrying amount of the financial liability de-recognised and the consideration paid/payable is recognised in profit or loss.

(iv) Offsetting financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet, if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle them on a net basis or to realise the assets and settle the liabilities simultaneously.

(v) Impairment of Financial Assets

Financial assets that are carried at amortised cost and fair value through other comprehensive income (FVOCI) are assessed for possible impairments basis expected credit losses taking into account the past history of recovery, risk of default of the counterparty, existing market conditions etc. The impairment methodology applied depends on whether there has been a significant increase in credit risk since initial recognition.

Expected Credit Losses are measured through a loss allowance at an amount equal to:

- The 12-months expected credit losses (expected credit losses that result from those default events on the financial instrument that are possible within 12 months after the reporting date); or
- Full lifetime expected credit losses (expected credit losses that result from all possible default events over the life of financial instruments).

For trade receivables or any contractual right to receive cash or another financial asset that result from transaction that are within the scope of Ind AS 115 and Ind AS 116, the Company measures the loss allowance at an amount equal to lifetime expected credit losses.

For other assets, the company uses 12 months ECL to provide for impairment loss where no significant increase in credit risk is. If there is significant increase in credit risk full lifetime ECL is used.

(vi) Write off

The gross carrying amount of a financial asset is written off when the Company has no reasonable expectations

of recovering the financial asset in its entirety or a portion thereof.

N. Impairment of Non-financial assets

Property, plant and equipment, other intangible assets and other non-financial assets are tested for impairment whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. For the purpose of impairment testing, the recoverable amount (i.e. the higher of the fair value less cost to sell and the value-in-use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the Cash Generating Unit (CGU) to which the asset belongs.

If such assets are considered to be impaired, the impairment to be recognized in the statement of profit and loss is measured by the amount by which the carrying value of the assets exceeds the estimated recoverable amount of the asset. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use.

The assets that suffered impairment are reviewed for possible reversal of the impairment at the end of each reporting period. When an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, however that the increased carrying amount does not exceed the carrying amount that would have been determined (net of any accumulated amortization or depreciation) had no impairment loss been recognised for the asset in prior years. The reversal of an impairment loss is recognised in the statement of profit and loss.

Impairment is reviewed periodically including at the end of each financial year.

O. Provisions, Contingent Liabilities and Contingent Assets

Provisions are recognized when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost.

A contingent liability is not recognised in the financial statements, however, is disclosed, unless the possibility of an outflow of resources embodying economic benefits is remote. If it becomes probable that an outflow of future economic benefits will be required for an item dealt with as a contingent liability, a provision is recognised in the financial statements of the period (except in the extremely rare circumstances where no reliable estimate can be made).

A contingent asset is not recognised in the financial statements, however, is disclosed, where an inflow of economic benefits is probable. When the realisation of income is virtually certain, then the asset is no longer a contingent asset, and is recognised as an asset.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date.

P. Dividends

Final dividends on equity shares are recorded as a liability on the date of approval by the shareholders and interim dividends are recorded as a liability on the date of declaration by the Board of Directors of the Company.

Q. Cash and cash equivalents

The Cash and cash equivalent in the balance sheet comprise cash at banks, cash on hand, demand deposits and short-term highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

R. Statement of Cash flows

The statement of cash flows is prepared in accordance with the Indian Accounting Standard (Ind AS) - 7 "Statement of Cash flows" using the indirect method for operating activities whereby profit for the period is adjusted for the effects of transaction of a non-cash nature, and item of income or expenses associated with investing or financing cash flows. The cash flows from operating, investing and financing activities of the company are segregated.

II. Current - Non-Current Classification

All assets and liabilities have been classified as current and non-current on the basis of the following criteria:

Assets

An asset is classified as current when it satisfies any of the following criteria:

- a) it is expected to be realised in, or is intended for sale or consumption in, the company's normal operating cycle;
- b) it is held primarily for the purpose of being traded;

- c) it is expected to be realised within twelve months after the reporting date; or
- d) it is cash or cash equivalent unless it is restricted from being exchanged or use to settle a liability for at least twelve months after the reporting date.

Current assets include the current portion of noncurrent financial assets.

All other assets are classified as non-current.

Liabilities

A liability is classified as current when it satisfies any of the following criteria:

- a) it is expected to be settled in the company's normal operating cycle;
- b) it is held primarily for the purpose of being traded;
- it is due to be settled within twelve months after the reporting date; or
- d) there is no unconditional right to defer settlement of the liability for at least twelve months after the reporting date. Terms of a liability that could, at the option of the counterpart, result in its settlement by the issue of equity instruments do not affect its classification.

Current liabilities include current portion of non-current financial liabilities.

All other liabilities are classified as non-current.

Operating cycle

Operating cycle is the time between the acquisition of assets for processing/servicing and their realisation in cash or cash equivalents. Based on the nature of products and the time between acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as twelve months for the purpose of current or non-current classification of assets and liabilities.

III. Significant Accounting Estimates, Judgements and Assumptions

The preparation of financial statements in conformity with Indian Accounting Standards (Ind AS) require management to make judgements, estimates and assumptions in the application of accounting policies that affect the reported amount of income, expenses, assets and liabilities and disclosure of contingent liabilities.

The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these



estimates. The estimates and underlying assumptions are reviewed on an ongoing basis and the effect of revision to accounting estimates is recognized prospectively from the period in which the estimate is revised.

Critical accounting estimates, Judgements and assumptions

i. Income taxes

Significant judgement is required in determination of provision for currenttax and deferred tax e.g. determination of taxability of certain incomes and deductibility of certain expenses etc. The carrying amount of income tax assets/liabilities is reviewed at each reporting date. The factors used in estimates may differ from actual outcome which could lead to signification adjustment to the amounts reported in financial statements.

ii. Defined Benefit Plans

The cost of the defined benefit plan and the present value of such obligation are determined using actuarial valuations. An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, future, salary increases, mortality rates etc. Due to the complexities involved in the valuation and its long-term nature, the obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each reporting date.

iii. Inventories

Management has estimated the net realizable values of inventories, taking into account the most reliable evidence available at each reporting date. The future realization of these inventories may be affected by market driven changes.

iv. Fair value measurement

Some of the company's assets and liabilities are measured at fair value for financial reporting process. In estimating the fair value of an asset or liability, the company uses market-observable data to the extent is available.

v. Provisions / Contingencies

Significant judgement is required for estimating the possible outflow of resources, if any, in respect of contingencies/claims/litigations against the Company which involves judgements around estimating the ultimate outcome of such past events and measurement of the obligation amount etc. The Company assesses such claims and monitors the legal environment on an ongoing basis, with the assistance of external legal counsel, wherever necessary.

vi. Useful lives of property plant and equipment and Intangible assets

The estimated useful lives of property plant and equipment and intangible assets are based on a number of factors including the effects of obsolescence, internal assessment of user experience and other economic factors (such as the known technological advancements, commercial obsolescence of the asset etc.). The useful life of property plant and equipment and intangible assets is reviewed on an ongoing basis.

vii. Recoverable amount of property, plant and equipment

The recoverable amount of property plant and equipment is based on estimates and assumptions regarding the expected market outlook and expected future cash flows. Any changes in these assumptions may have a material impact on the measurement of the recoverable amount and could result in impairment.

IV. Applicability of New and Revised Ind AS

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time. On March 31, 2023, MCA amended the Companies (Indian Accounting Standards) Amendment Rules, 2023, as below:

- i. Ind AS 12 Income Taxes This amendment has narrowed the scope of the initial recognition exemption so that it does not apply to transactions that give rise to equal and offsetting temporary differences. The effective date for adoption of this amendment is annual periods beginning on or after April 1, 2023. The Company has evaluated the amendment and there is no impact on its financial statements. The Company does not expect this amendment to have any significant impact on its financial statements.
- ii. Ind AS 1 Presentation of Financial Statements This amendment requires the entities to disclose their material accounting policies rather than their significant accounting policies. The effective date for adoption of this amendment is annual periods beginning on or after April 1, 2023.
- iii. Ind AS 8 Accounting Policies, Changes in Accounting Estimates and Errors This amendment has introduced a definition of 'accounting estimates' and included amendments to Ind AS 8 to help entities distinguish changes in accounting policies from changes in accounting estimates. The effective date for adoption of this amendment is annual periods beginning on or after April 1, 2023.

The Company has an obligation towards gratuity, a defined benefit retirement plan covering eligible employees and this is a non-funded plan. The Company accounts for the liability for gratuity benefits payable in the future based on actuarial valuation using projected unit credit method.

The defined benefit plans typically expose the Company to actuarial risks such as interest rate risk, longevity risk and salary risk.

Salary Risk

The present value of defined benefit plan is calculated with the assumption of salary increase rate of plan participants in future. Deviation in rate of increase in salary in future for plan participants from the rate of increase in salary used to determine the present value of obligation will have a bearing on the plan's liability.

Interest Risk

The plan exposes the Company to the risk of fall in interest rates. A fall in interest rates will result in an increase in the ultimate cost of providing the above benefit and will thus result in an increase in value of the liability.

Longevity Risk

The present value of defined benefit plan liability is calculated by reference to the best estimate of the mortality of plan participants both during and after employment. An increase in the life expectancy of the plan participants will increase the plans liability.

Notes to reconciliations

- (a) Under Previous GAAP, Lease payments under a lease agreement identified as operating lease are recognised as expense in the statement of profit and loss on a systematic basis over the lease term. Under Ind AS, except certain cases, lessee needs to recognise a right-of use asset and a lease liability at the commencement of lease at the initial cost paid and present value of future lease payments at that date. Subsequently, the asset is amortized over lease period and the carrying amount of lease liability is increased to reflect interest on the lease liability and is reduced to reflect the lease payments made during the year. The effect of this change results in recognition of 'Right-of-use asset' amounting to ₹ 62.86 Lakhs with corrosponding recognition of 'Lease liabilities' as at April 1, 2021. This has also resulted in increase in 'Finance cost' amounting to ₹ 4.23 Lakhs, increase in 'Depreciation and amortization expense' amounting to ₹ 7.16 Lakhs and decrease in 'Other expense' amounting to ₹ 9.60 Lakhs in the statement of profit and loss for the year ended March 31, 2022. Further, this has resulted in net decrease in 'Other equity' amounting to ₹ Nil and ₹ 1.78 Lakhs as at April 1, 2021 and March 31, 2022 respectively. The said adjustment has resulted in increase in 'Cash used in financing activities' for the year ended March 31, 2022 by ₹ 9.60 Lakhs with corresponding impact in 'Cash from operating activities'.
- (b) As per Ind AS 109, the Company is required to apply expected credit loss model for recognising the allowance for doubtful debts. As a result, the Company has provided allowance for doubtful debts in respect of 'Trade receivables' amounting to ₹ 38.52 Lakhs and ₹ 42.94 Lakhs as at April 1, 2021 and March 31, 2022 respectively. This has resulted in increase in 'Other expenses' amounting to ₹ 4.42 Lakhs for the year ended March 31, 2022. This has further resulted in decrease in 'Other equity' amounting to ₹ 38.52 Lakhs and ₹ 42.94 Lakhs as at April 1, 2021 and March 31, 2022 respectively. This has no effect on 'Statement of cash flows' of the Company.
- (c) Under Previous GAAP, gains and losses on remeasurement and return on plan assets, excluding amounts included in the net interest expense of post employment defined benefit plans are recognised in profit and loss. Under Ind AS, there are recognised in 'Other comprehensive income'. Consequently, the tax effect of the same is also recognised in other comprehensive income. The effect of this change has resulted in increase in 'Employee benefits expenses' by ₹ 5.63 Lakhs in the Statement of profit and loss for the year ended March 31, 2022 with corrosponding increase in other comprehensive income for the year ended March 31, 2022. This has no effect on 'Other Equity' and 'Statement of cash flows' of the Company.
- (d) Under the previous GAAP, deferred tax accounting is done using income statement approach, which focuses on timing differences between taxable profits and accounting profits for the period. Ind AS 12 'Income Taxes' requires to account for deferred taxes using the balance sheet approach, which focuses on temporary differences between the carrying amount of an asset or liability in the balance sheet and its tax base. In addition, the transitional adjustments also lead to new temporary differences. This has resulted in recognition of deferred tax on temporary differences which was not required under previous GAAP. This has resulted in net increase in 'Deferred tax assets' amounting to ₹ 10.72 Lakhs and ₹ 12.45 Lakhs as at April 1, 2021 and March 31, 2022 respectively with coresponding impact in 'Other equity'. This has further resulted in recognition of deferred tax income amounting to ₹ 3.29 Lakhs in profit or loss and recognition of deferred tax expense amounting to ₹ 1.57 Lakhs in other comprehensive income.
