With reference to above captioned subject matter, Outcome of Board Meeting dated 15th March, 2019, whereby the Company intimated that the Board of Directors of the Company have approved the proposal of acquisition of 100% stake of Madhya Bharat Phosphates Private Limited (hereinafter "MBPL") through National Company Law Tribunal, Ahmedabad Bench (hereinafter "NCLT") under the Insolvency & Bankruptcy Code, 2016 (hereinafter "IBC") and in pursuance of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, we would like to inform that the NCLT, has approved the Resolution Plan for proposed takeover of MBPL, to which the Company was Resolution Applicant, pursuant to provisions of IBC.

The Company is acquiring 100% stake in MBPL. The unit of MBPL located in Madhya Pradesh, has two plants at Jhabua and Deewanganj has a capacity to manufacture SSP of 1.5 Lac MTA and 0.4 Lac MTA, respectively, and a Plant for a manufacture of LABSA.
