Subject: Notice of Offer for Sale (OFS) of 79,51,112 Equity Shares (“Shares”) of Re.1/- each of TPI India Limited (BSE Scrip Code: 500421) by Promoter – Mr. Bharat Chimanlal Parekh through the Stock Exchange Mechanism (the “OFS Notice”)

We wish to inform you that pursuant to,

- (a) The ‘Comprehensive Framework on Offer for Sale (OFS) of Shares through Stock Exchange Mechanism’ issued by the Securities and Exchange Board of India (“SEBI”) vide its circular no. SEBI/HO/MRD/MRD-PoD-3/P/CIR/2023/10 dated January 10, 2023 (the “SEBI OFS Circular”),
- (b) The ‘Revised Operational Guidelines for Offer for Sale (OFS) Segment’ issued by BSE, vide its notice no. 20230127-14 dated January 27, 2023,

Mr. Bharat Chimanlal Parekh (“Seller”), a part of the promoter group of **TPI India Limited** (the “**Company**”), proposes to sell **79,51,112 equity shares** of face value of **Re.1/-** each representing **18.51%** of the share capital of the Company (**hereinafter referred to as ‘Sale Shares’**) on April 23, 2024 (‘T Day’) (for Non-Retail Investors) and April 24, 2024 (‘T + 1 Day’) (for Retail Investors as well as for Non-Retail Investors, who choose to carry forward their un-allotted bids from T day) through a sale on the separate window provided by BSE Limited.

This Notice is being issued to the Stock Exchanges, pursuant to Clause 5(2) of the SEBI OFS Circular to announce the intention of the Seller to undertake the OFS and contains important details with respect to the OFS. Bidders and prospective investors as well as their brokers are requested to read the entire contents of this Notice, along with the SEBI OFS Circular, before participating in the OFS.

The OFS is being undertaken by the Seller for achieving the minimum public shareholding in the Company, as prescribed under Rule 19(2)(b) and Rule 19A of the Securities Contracts (Regulation) Rules, 1957 and Regulation 38 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015. Offer for Sale is one of the methods that has been prescribed by SEBI Circular no. SEBI/HO/CFD/PoD2/P/CIR/2023/18 dated February 3, 2023 as an acceptable method for achieving minimum public shareholding criteria.

The OFS shall be undertaken exclusively through the Seller's Broker (defined later) on a separate window provided by BSE Limited for this purpose.

BSE Limited will be carrying out the activities of the designated stock exchange ("DSE"). The Seller shall deposit the Sale Shares with the National Clearing Corporation Limited ("NSCCL") being the designated clearing corporation.
