• From Office of Deputy Commissioner of State Tax, Uttar Pradesh under Section 73 of Central Goods and Service Tax Act/Uttar Pradesh Goods and Service Tax Act for Tax liability amounting to Rs. 22,50,000, Interest of Rs. 22,27,500 and a penalty of Rs. 2,25,000 aggregating to a demand of Rs. 47,02,500. The said demand is raised on some part of the credit notes issued.

Based on our assessment, we believe that the aforementioned demand is not maintainable, and the Company is in the process of preferring appeals against the said Order. The Order has no material impact on the financials, operations or other activities of the Company.
