**PROCEEDINGS OF 21ST ANNUAL GENERAL MEETING (AGM) OF
INDRAPRASTHA GAS LIMITED**

21st Annual General Meeting of the Company was held on 28th September, 2020 at 11.30 AM through Video Conferencing (VC).

Shri P.K. Gupta, Chairman of the Company took the Chair and welcomed the members. Thereafter, he introduced the Directors present in the meeting. The quorum being present, the Chairman called the meeting to order. He informed that the Meeting was convened through VC in compliance with the circulars issued by the Ministry of Corporate Affairs.

Company Secretary informed that, the Company had provided e-voting facility to its members between 9.00 AM on 25th September, 2020 to 5.00 PM on 27th September, 2020 to cast their votes on the resolutions proposed in the Notice of the Annual General Meeting. Those members who could not cast their votes electronically during e-voting period, facility for e-voting (instapoll) was available for 15 minutes after the conclusion of AGM.

Company Secretary mentioned that Shri V. K. Sharma, Company Secretary in whole time practice was appointed as Scrutinizer to conduct the scrutiny of e-voting as well as instapoll voting at the Annual General Meeting in a fair and transparent manner.
