

his closest rival PTI-backed Muhammad Ruman Ahmad, who got 129,716 votes. The margin of victory was 11,804 while the number of National ballot papers rejected was 24,547. It was followed by NA-215 Umerkot (17,571 ballots). The lowest number of ballots excluded are reported from NA-236 Karachi East-II (51 ballots). In total, around two million ballot papers have been excluded from the count from the 265 National Assembly constituencies.

Despite independent candidates backed by jailed former prime minister Imran Khan's Pakistan Tehreek-e-Insaf (PTI) party winning the most seats in parliament, questions loom over what the next government of Islamabad will look like. None of the three major parties - the PML-N, the PPP or the PTI have the necessary votes to secure majority in the 266-member national Assembly and, therefore, will be unable to form government on their own, leaving it unclear who will be picked as the shrapnel government's next prime minister.

The leaders of PML-N and PPP discussed the idea of appointing a prime minister for all the terms during their first meeting held on Sunday following the February 8 elections as part of their efforts to form a coalition government in the centre and provinces, according to a source privy to the development. "It has been proposed that PML-N candidate will get a five-year term, while PPP's leader will get a two-year term,"
