

1. As per the Notice of 25<sup>th</sup> Annual General Meeting of the Shareholders and the 'Advertisement' published pursuant to Rule 20(4)(v) of the Companies [(Management and Administration) Rules, 2014] (Amendment Rules, 2015) on August 28, 2018, in English Newspaper "Business Line" and in Marathi (Vernacular) Newspaper "Deshdoot", the remote e-voting opened at 09.30 A.M. (IST) on Sunday, September 16, 2018 and remained open until 05.00 P.M. (IST) on Tuesday, September 18, 2018.
2. The Shareholders holding the Equity Shares of the Company as on Wednesday, September 12, 2018 viz. the "cut-off date", were entitled to vote on the resolutions stated in the Notice of the 25<sup>th</sup> Annual General Meeting of the Company.
3. After the declaration of voting by use of ballot by the Chairman at the meeting, ballot box was locked and kept for voting duly marked by identification mark placed on them. The ballot box subsequently on close of voting hours was opened in the presence of two witnesses who are not the employees of the Company, and ballots received were serially numbered, sorted, signatures verified and were scrutinized and initialed by the scrutinizer. The ballots were reconciled with the records maintained by the Company/ Registrar and Transfer Agents (R&TA) of the Company and the Authorizations / proxies lodged with the Company.
4. The ballots, which were found incomplete and / or which were otherwise found defective have been treated as invalid and kept separately.
5. The votes on remote e-voting were unblocked, in the presence of two witnesses who are not the employees of the Company, at around 1.27 P.M. after conclusion of voting at the AGM and the e-voting results / list of Equity Shareholders who voted for and against were downloaded from the e-voting website of Link Intime India Private Limited [www.linkintime.co.in](http://www.linkintime.co.in) and the same are being handed over to the Chairman.



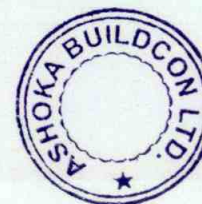


