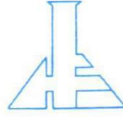

## **IMPACT OF COVID-19**

### **A. Major challenges/constraints faced during Covid-19:**

Due to lockdown following hurdles are being faced by HFL:

- One of our major raw material AHF is coming from Cuddalore, Tamilnadu. Due to lockdown HFL is facing transportation hurdles and due to which plant is shut down for want of raw material.
- The dealer network/retail network selling CFM-22 is facing problem in selling the product, due to which HFL is not getting collections from the customers.

### **B. Activities/ measures taken to overcome the challenges:**

To overcome the above hurdle, HFL officials are in constant touch with suppliers as well as dealer network/retail network selling CFM-22 to enable receipt of raw material and selling CFM-22.

### **C. 20% Reduction in expenses- Action taken:**

Due to paucity of funds and working capital issues HFL is paying 80% salary to its employees to ensure running of plant. Further, conscious efforts are being made to see that operational expenses are minimal.

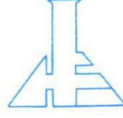
### **D. Loss of Revenue during March, 25<sup>th</sup> 2020 to April, 30<sup>th</sup> 2020:**

During the period of lockdown from 25-03-2020 to 30-04-2020, company has incurred revenue loss of Rs.461.48 lakhs [4.5 MT per day @ Rs.2,93,000 per MT]

### **E. Major initiatives/steps taken during Covid-19:**
