	Brief details of dispute/litigation	<p>The Company had filed a Writ petition no. 7352/2024 on March 7, 2024 with Hon'ble High Court of Karnataka to potentially avoid any action under section 83 of the CGST/ KGST Act. The petition was heard on the same day and stay was granted till next hearing. Subsequently, another Writ Petition no. 10145/2024 was filed by the Company on March 28, 2024 in pursuance to show cause notice received under section 74 of the CGST Act.</p> <p>The Writ petition no. 7352/2024 came up for further hearing on April 10, 2024. The Hon'ble High court has disposed off the Writ petition since another Writ Petition no. 10145/2024, as mentioned above, has been filed against the show cause notice.</p> <p>Further, the Hon'ble High Court has reserved the liberty in favour of the Company to approach the Court in case any coercive action is taken by the opposing party in future.</p>
