and based on the above examination, We hereby report that, during the Review Period:

- (a) The listed entity has complied with the provisions of the above Regulations and circulars/ guidelines issued there under except in respect of matters specified hereunder:
 - i. As per Regulation 17 (1) (c) of the SEBI Listing Obligations and Disclosures Requirements Regulations, 2015 (Listing Regulations), the Board of Directors of the listed entity shall comprise of not less than six directors. It was observed during the review period that the term of Mr. Nagarjun Valluripalli expired on August 5, 2019. Consequently, the no. of the directors reduced below six (6). The Board comprised of only five (5) members during the period from November 9, 2019 to January 31, 2020. The listed entity at its Board meeting held on February 1, 2020 appointed Dr. Ramadevi Gourineni as an additional director and complied with Regulation 17 (1) (c) of Listing Regulations.
 - ii. As per CIRCULAR NO.CIR/CFD/CMD1/27/2019 dated 8th February, 2019, every listed entity shall submit the annual secretarial compliance report within 60 days of the end of the financial year. However the listed entity submitted the above said report on 6th June, 2019.
- (b) The listed entity has maintained proper records under the provisions of the above Regulations and circulars/ guidelines issued there under insofar as it appears from our examination of those records.
- (c) There were no actions taken against the listed entity/ its promoters/ directors/ material subsidiaries (Not applicable to this company) either by SEBI or by Stock Exchanges (including under the Standard Operating Procedures issued by SEBI through various circulars) under the aforesaid Acts/ Regulations and circulars/ guidelines issued there under except as reported hereunder:
