Sub: Sale and transfer of MP Power Transmission Package-II Limited, wholly owned subsidiary of RECPDCL and also of REC.

Dear Sir(s),

This is to inform that MP Power Transmission Package-II Limited, a special purpose vehicle (SPV) and wholly owned subsidiary of REC Power Development and Consultancy Limited (RECPDCL), which is a wholly owned subsidiary of REC, was incorporated for development of intra-state transmission work (Package – II) in Madhya Pradesh through Tariff Based Competitive Bidding (TBCB). The above SPV was to be transferred to the successful bidder selected through TBCB process.

After successful completion of TBCB process, Adani Transmission Limited emerged as successful bidder for the said project. Accordingly, after receipt of consideration comprising of professional fee for bid process coordination and reimbursement of expenditure incurred on the project by RECPDCL, interest cost etc., the entire shareholding of MP Power Transmission Package-II Limited, comprising of 50,000 equity shares, presently held by RECPDCL, has been transferred at par value along with all its assets and liabilities on November 1, 2021 to Adani Transmission Limited.

Hence, with effect from the aforesaid date, the above project specific SPVs are not subsidiaries of RECPDCL & REC.
