भारतीय रिजर्व बैंक के हस्तक्षेप के चलते ल का उत्पादन

मंबई. 14 सितंबर

देशी मुद्रा भंडार सितंबर के पहले हफ्ते में घटकर 400 अरब डॉलर के नीचे चला गया। 11 नवंबर 2017 के बाद पहली बार ऐसा हुआ है। 7 सितंबर को विदेशी मुद्रा भंडार 399.28 अरब डॉलर पर रहा। ऐसे समय में आरबीआई के हस्तक्षेप के चलते यह देखने को मिला जब पोर्टफोलियो निवेश की कुछ वापसी दिख रही है। इस साल अप्रैल के मध्य में मुद्रा भंडार 426 अरब डॉलर के उच्चस्तर पर पहुंच गया था जब डॉलर के मुकाबले रुपया करीब 65 पर था। हालांकि इसमें गिरावट शुरू हो गई क्योंिक केंद्रीय बैंक को मई में रुपये को थामने के लिए हस्तक्षेप करना पड़ा। इस हफ्ते डॉलर के मुकाबले रुपया रिकॉर्ड निचले स्तर 72.91 पर चला गया, जिसके बाद सरकार को बयान देना पड़ा कि वह कुछ कदम उठा रही है।
