मुद्रा भंडार 400 अरब डॉलर फोकसवैगन बंद

भारतीय रिजर्व बैंक के हस्तक्षेप के चलते मुद्रा का उत्पादन

विदेशी मुद्रा भंडार सितंबर के पहले हफ्ते में घटकर 400 अरब डॉलर के नीचे चला गया। 11 नवंबर 2017 के बाद पहली बार ऐसा हुआ है। 7 सितंबर को विदेशी मुद्रा भंडार 399.28 अरब डॉलर पर रहा। ऐसे समय में आरबीआई के हस्तक्षेप के चलते यह देखने को मिला जब पोर्टफोलियो निवेश की कुछ वापसी दिख रही है। इस साल अप्रैल के मध्य में मुद्रा भंडार 426 अरब डॉलर के उच्चस्तर पर पहुंच गया था जब डॉलर के मुकाबले रुपया करीब 65 पर था। हालांकि इसमें गिरावट शुरू हो गई क्योंकि केंद्रीय बैंक को मई में रुपये को थामने के लिए हस्तक्षेप करना पड़ा। इस हफ्ते डॉलर के मुकाबले रुपया रिकॉर्ड निचले स्तर 72.91 पर चला गया, जिसके बाद सरकार को बयान देना पड़ा कि वह कुछ कदम उठा रही है।

बुधवार को आर्थिक मामलों के सचिव सुभाष चंद्र गर्ग ने ट्वीट में कहा था, रुपये में गिरावट बाजार के ऑपरेटरों की जरूरत से ज्यादा प्रतिक्रिया को प्रतिबिंबित करता है। उसके बाद से रुपये में काफी सुधार हुआ और शुक्रवार को यह डॉलर के मुकाबले 71.86 पर बंद हुआ। मुद्रा बाजार शिकायत कर रहा था कि आरबीआई पर्याप्त हस्तक्षेप नहीं कर रहा है और वह

भारतीय रिजर्व बैंक ने शुक्रवार को द्वितीयक बाजार से 100 अरब रुपये खरीदेगा, जो मौजूदा नकदी की स्थिति और आने वाले समय के लिए टिकाव के लिए रखे हुए किया जाएगा।

इस साल यह खुले बाजार में चौथी (ओएमओ) है और अग्रिम कर के लिए रहा है। इस हफ्ते ओवरनाइट कॉल में अंक बढ़ गया था क्योंकि लेनदारों ने नकदी नहीं निकाली। इस अनुमान में किया कि अग्रिम कर के चलते आगे नकदी देखने को मिल सकती है।

नकदी की स्थिति सख्त होने का कारण क्योंकि आरबीआई रुपये को स्थिर रखने का बाजार में डॉलर बेच रहा है। इस वक्री नकदी बाजार से निकल जाती है। नकदी की किल्लत हो जाती है। बॉन्ड भी बढ़ने लगा है और शुक्रवार को
