Subject: Outcome of the Meeting of Board of Directors of the Bank - disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015

In continuation to our letter no. ISD/19-20/52 dated May 10, 2019 regarding intimation of meeting of Board of Directors of the Bank, we wish to inform you that the Board of Directors in its meeting held on May 15, 2019 has approved the Capital Plan of the Bank for FY 2019-20 as under:

- To raise total capital funds upto Rs.6000 crore during the FY 2019-20 in the form of Core Equity Capital and/or Additional Tier I (AT I) Bonds and/or Tier 2 Bonds, subject to maximum issue of Rs.4200 crore of Additional Tier I (ATI) Bonds and/or Tier 2 Bonds within the overall capital raising limit of Rs.6000 crore.
- To raise Equity Capital not exceeding Rs.4900 crore, within the overall limit of Rs.6000 crore during FY 2019-20 through Public Issue (i.e. Follow-on Public Issue) and/or Rights Issue and/or Private Placement including Qualified Institutional Placement and/or Preferential allotment to Government of India or other Institutions and/or any other mode(s) subject to approval by Government of India, other regulatory authorities and of the shareholders in the General Meeting as and when applicable.

Approval of the shareholders for raising of equity capital would be sought at the Annual General Meeting (AGM) to be held on Friday, June 28, 2019. The Notice of AGM and the Annual Report for FY 2018-19 will be sent to the stock exchanges and the shareholders in due course.

The Board meeting commenced at 11:15 AM and concluded at 05:30 PM.

The above disclosure is made under Regulation 30 read with entry no. 4 of Para A of Part A of Schedule III of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015.
