Sub: Business update with reference to COVID-19 situation - regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to the regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation of our earlier disclosure dated 26th March, 2020 and 2nd May, 2020, we wish to inform you that:

The Company has re-started most of its factories and resumed manufacturing activities in Telangana, Andhra Pradesh, Uttar Pradesh, and Maharashtra, barring few factories after obtaining prior permissions from the concerned District/ Government Authorities. The Company is taking all pre-cautionary measures for safety and health of its employees.

Further most of the important projects of Drinking Water supply and Irrigation projects in Telangana, Andhra Pradesh, Karnataka, Madhya Pradesh, Chhattisgarh, Rajasthan, Tamil Nadu, Haryana, Maharashtra and Gujarat have re-started mobilizing labour and materials for site activities of laying, jointing, testing and civil works after obtaining prior permissions from the concerned District/ Government Authorities. In respect of Drainage projects in Karnataka laying activities have resumed.

Few of the project offices in Telangana, Karnataka and Maharashtra have started functioning with limited staff.

Registered office of the Company and other offices barring a few continue to remain closed. The Company is abiding with COVID-19 directives. The Company has taken appropriate steps including Work from Home policy to ensure safety and health of the Company's employees at Head office and other locations.

In the wake of COVID-19, availability of labour coupled with restrictions on movement continues to pose challenges. The situation remains fluid as duration and scope of COVID-19 is continuously evolving. Hence it is not possible to estimate the extent of its impact on the business at this time. The Company is monitoring the situation and will take appropriate measures as per Central/States directives from time to time to ensure health and safety of its employees.

We will update the Exchange on happening of further material developments on Covid-19 situation.
