I, Ms. Rupal D. Jhaveri, Practicing Company Secretary (Membership No. 5441 and Certificate of Practice No. 4225), have been appointed as Scrutinizer by Kotak Mahindra Bank Limited (the "Bank") in its Board Meeting held on 22nd April 2020 to scrutinize the postal ballot (conducted through electronic means) in a fair and transparent manner and ascertaining the requisite majority on the said postal ballot carried out pursuant to Section 110 of the Companies Act, 2013 (the "Act") read with Rule 22 of the Companies (Management and Administration) Rules, 2014 (the "Rules") as amended from time to time read with the General Circular No. 14/ 2020 dated April 8, 2020 and the General Circular No. 17/ 2020 dated April 13, 2020 ("MCA Circulars"). I submit my report as under:

- 1. The Postal Ballot Notice along with Explanatory Statement under Section 102 of the Act was sent to all the Members whose e-mail id's were registered with Depositary Participants/ Bank and whose names appeared in the Register of Members/List of Beneficial Owners as received from National Securities Depository Limited ("NSDL") and Central Depository Services (India) Limited ("CDSL", together with NSDL, the "Depositories") and available with the Bank as on Friday, April 17, 2020 ("Eligible Members"). A copy of this Postal Ballot Notice is also available on the website of the Bank (www.kotak.com), the relevant section of the website of the Stock Exchanges on which the Equity Shares of the Bank are listed and the website of KFin Technologies Private Limited ("KFintech") (http://evoting.karvy.com).
- 2. On account of the threat posed by COVID-19 and in terms of the MCA Circulars, the Bank had sent the postal ballot notice in electronic form only and the same was completed on Thursday, April 23, 2020. The hard copy of this Postal Ballot Notice along with postal ballot forms and pre-paid business envelope was not sent to the members for the postal ballot in accordance with the provisions specified under the MCA Circulars. Accordingly, the communication of the assent or dissent of the members had taken place through the remote e-voting system only.
- 3. The e-voting commenced on Saturday, April 25, 2020 (9:00 a.m. onwards) and ended on Sunday, May 24, 2020 (5:00 p.m.). The e-voting services were provided by KFintech.

- 4. All the data of e-voting i.e. the results of e-Voting alongwith the list of shareholders who voted "For" and "Against" the Resolution were downloaded from the e-voting portal of KFintech, by unblocking the event on Sunday, May 24, 2020 around 5:01 p.m.
- 5. All votes casted through e-voting upto 5.00 p.m., Sunday, May 24, 2020, the last date and time fixed by the Bank, were considered for scrutiny.
- 6. The summary of the results of the postal ballot conducted through e-voting are as under:
