We hereby inform you that the 87th Annual General Meeting (AGM) of the shareholders of the Company shall be held on Wednesday, 30th August, 2023 at 2.00 P.M. IST through Video-Conferencing ("VC") / Other Audio-Visual Means ("OAVM") in compliance with the applicable provisions of the Companies Act, 2013, read with the Ministry of Corporate Affairs, Government of India, General Circulars No. 20/2020 dated 5th May, 2020 & No. 10/2022 dated 28th December, 2022. The Register of Members and Share Transfer Books of the Company shall remain closed from Thursday, 24th August, 2023 to Wednesday, 30th August, 2023 (both days inclusive) for the purpose of holding the said AGM and for the purpose of payment of dividend @ 30% i.e. Rs. 3/- per equity share of the nominal/ face value of Rs. 10/- each for the Financial Year ended 31st March, 2023, if declared by the shareholders at the said AGM.

Accordingly, the record date for the purpose of payment of the said dividend shall be Wednesday, 23rd August, 2023, i.e. the members whose names appear in the Register of Members of the Company at the close of business on Wednesday, 23rd August, 2023, shall alone be entitled to the said Dividend.

Besides, an E-Voting System during the course of the AGM, namely the Insta Poll, shall also be available for the shareholders participating at the meeting in accordance with the aforementioned Circulars.

The cut-off date for ascertaining the names of shareholders who shall be entitled to exercise their votes through the Remote Electronic-Voting Facility or through the Insta Poll shall be Wednesday, 23rd August, 2023.
