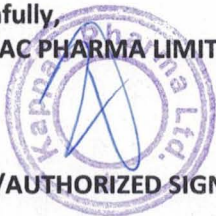

Opinion


