Sub: Report of Scrutinizer for the Postal Ballot Process vide Notice Dated 8th February, 2023 under section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 by Star Health and Allied Insurance Company Limited ('the Company')

The Board of Directors of the Company had appointed me as a Scrutinizer for scrutinizing the postal ballot voting including e-voting process in connection with Postal Ballot conducted in terms of General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 8, 2021 and 3/2022 dated May 5, 2022 read with other relevant circulars, including General Circular No. 10/2021 dated June 23, 2021, General Circular No. 20/2021 dated December 08, 2021 and General Circular No. 11/2022 dated 28th December 2022, issued by the Ministry of Corporate Affairs (collectively referred as "MCA Circulars") for the purpose of scrutinizing the electronic voting process through remote e-voting ("e-voting") in a fair and transparent manner in terms of the resolution of the Board of Directors of the Company dated 8th February, 2023.

The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013, MCA Circulars and Rules relating to e-voting on the resolutions contained in the Notice of Postal Ballot dated 8th February, 2023. Our responsibility as a scrutinizer for the voting process through e-voting is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the evoting system of M/s KFin Technologies Limited ("KFin"), the agency engaged by the Company to provide e-voting facility.

The postal ballot process was accordingly conducted and concluded as below:

• The Company on 16th February, 2023 dispatched the notice under section 110 of the Companies Act, 2013 to all the members of the Company whose names appeared on the Register of Members/ List of Beneficiaries as on 10th February, 2023.

- The Company issued an advertisement in Business Standard and Dinamani newspapers about the dispatch of Postal Ballot Notice on 16th February, 2023.
- The e-Voting process commenced on Monday, 20th February 2023 (10.00 A.M.) and was open up to the close of working hours at 5.00 P.M. on Tuesday, 21st March, 2023.
- All electronic votes received up to the close of working hours at 5.00 P.M. on 21st March, 2023, were considered for my scrutiny.
- The votes cast by the members through electronic voting system was downloaded and collected from the website www.evoting.kfintech.com
- A register containing the details of assent or dissent, received, mentioning the particulars of name, address, folio number / client ID of the shareholders, the number of shares held by them, the nominal value of shares held etc. is maintained in electronic form
- Since the voting on Postal Ballot Process was conducted only through e-voting, reporting on number of envelopes containing postal ballot form received after due date and up to the date of this report does not arise.
- Since the voting on Postal Ballot Process was conducted only through e-voting, reporting on number of envelopes containing postal ballot forms returned undelivered also does not arise.
- Since the voting on Postal Ballot Process was conducted only through e-voting, reporting on finding of defaced or mutilated ballot paper too does not arise
