Sub: Intimation of revised date of Board Meeting and closure of Trading Window

Dear Sirs,

This is further to our Letter No.JAL:SEC:SE/2020 dated July 24, 2020 informing the Exchanges about the date of next meeting of the Board of Directors of the Company as 31st July, 2020, inter-alia, to consider and approve the Un-audited Standalone and Consolidated Financial Results of the Company for the quarter ended 30th June, 2020.

In view of the COVID related impediments/restrictions including exponential increase in containment zones, it is taking some more time than expected to finalise the Financial Results.

As such, the next meeting of the Board of Directors of the Company will now be held on Wednesday, the 5<sup>th</sup> August, 2020, (instead of 31<sup>st</sup> July, 2020 as intimated earlier) inter-alia, to consider and approve the Un-audited Standalone and Consolidated Financial Results of the Company for the quarter ended 30<sup>th</sup> June, 2020.

As already intimated vide our letter dated 30<sup>th</sup> June, 2020, pursuant to SEBI (Prohibition of Insider Trading) Regulations, 2015 as amended by SEBI (Prohibition of Insider Trading) (Amendment) Regulations, 2018 and in accordance with the Code of Conduct to Regulate, Monitor and Report Trading by Insiders for trading in listed securities, the Trading Window has already been closed from 1<sup>st</sup> July, 2020 and shall now remain closed till 7<sup>th</sup> August, 2020 (evening). Accordingly, the Trading Window shall re-open from the 8<sup>th</sup> August, 2020 (9.00 A.M.).

During the aforesaid closed trading window period, the Employees, Directors, Key Managerial Personnel and Designated Persons and their immediate relatives shall not trade in Company's shares/securities.
