Report on the audit of the Standalone Financial Results

Opinion

We have audited the accompanying annual standalone financial results of INTERFACE **FINANCIAL SERVICES LIMITED** ("the company") for the quarter and year ended on 31/03/2023, attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Listing Regulations').
