b) BSE vide its notice number 20240213-33 dated February 13, 2024 ("BSE Final Delisting Approval") has communicated that Equity Shares of the Company (BSE Scrip Code: 514484) shall be discontinued from trading w.e.f. February 20, 2024 ("BSE Date of Discontinuance of Trading") and the above referred Scrip Code will be delisted from BSE with effect from February 27, 2024 ("BSE Date of Delisting").

2. OUTSTANDING EQUITY SHARES AFTER DELISTING

a) In accordance with Regulation 26 of the SEBI Delisting Regulations and as announced earlier in the Post Offer PA, the Residual Public Shareholders who did not or were not able to participate in the Reverse Book Building Process or who unsuccessfully tendered their Equity Shares in the Reverse Book Building Process and are currently holding Equity Shares will be able to tender their Equity Shares to the Promoter Acquirer at Rs. 20/- per Equity Share ("Exit Price") for a period of one year from the BSE Date of Delisting.
