I, Atul Kumar Labh, Practising Company Secretary (FCS – 4848 / CP - 3238) and proprietor of M/s. A. K. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013, MCA Circulars and the Rules relating to remote e-voting and e-voting at the AGM on the resolutions contained in the Notice of the AGM dated the 11<sup>th</sup> day of August, 2022. My responsibility as a scrutinizer for remote e-voting and e-voting at the AGM is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the e-voting system of National Securities Depository Limited ("NSDL"), the agency engaged by the Company to provide the facilities for both remote e-voting at the AGM.

- The remote e-voting period remained open from 09:00 A.M. IST on Wednesday, the 21<sup>st</sup> day of September, 2022 up to 5:00 P.M. IST on Sunday, the 25<sup>th</sup> day of September, 2022.
- The shareholders holding shares as on the "cut off" date, i.e. the 19<sup>th</sup> day of September, 2022 were entitled to vote on the proposed 5 (Five) resolutions as mentioned in the Notice of the AGM dated the 11<sup>th</sup> day of August, 2022.
- The Company had also provided e-voting facility at the AGM to enable the shareholders attending the AGM through VC / OAVM to cast the votes in case the same had not been cast by them through remote e-voting.
- 4. The votes were unblocked on Monday, the 26<sup>th</sup> day of September, 2022 around 12:30 P.M.
