

NOTICE of Postal Ballot ("Notice") is hereby given to the Members of Rites Limited ("the Company"/"Rites") pursuant to Section 110 read with Section 108 and other applicable provisions, if any, of the Companies Act, 2013, ("Act") read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014, (including any statutory modification(s) or re- enactment(s) thereof for the time being in force) ("Rules"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"/ "Listing Regulations"), Secretarial Standards on General Meetings issued by The Institute of Company Secretaries of India ("SS-2"), as amended and in accordance with the circulars issued by the Ministry of Corporate Affairs ("MCA") for holding general meetings/ conducting postal ballot process through e-voting vide General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 02/2021 dated January 13, 2021,10/2021 dated June 23, 2021 and 20/2021 dated December 08, 2021 ("MCA Circulars"), in view of the COVID-19 pandemic, it is proposed to seek the consent of Members of RITES Limited ("the Company") to transact the Special business as set out in this Postal Ballot Notice by passing Ordinary Resolution through voting by electronic means ("remote e-voting") only.

On account of the threat posed by COVID-19 pandemic and in terms of the requirements specified in the said MCA Circulars, this Postal Ballot Notice is being sent in electronic form only, to all its Members who have registered their e-mail addresses with the Company/Registrars and Share Transfer Agent/Depository/Depository Participants and the communication of assent/dissent of the Members will only be taken through the remote e-voting system and whose

EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013, SEBI (LODR) REGULATIONS AND SECRETARIAL STANDARD-2, CONTAINING MATERIAL FACTS IN RESPECT OF ITEMS OF SPECIAL BUSINESS SET OUT IN THIS POSTAL BALLOT NOTICE

The following Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014, SEBI (LODR) Regulations and Secretarial Standard-2, sets out all material facts relating to the items of Special Business set out in this Postal Ballot Notice.

ITEM NO.- 1: APPOINTMENT OF SHRI RAJ KUMAR MANGLA (DIN: 09533985) AS PART TIME GOVERNMENT NOMINEE DIRECTOR

As per the Article 56 of Articles of Association of the Company, President of India, has the power to appoint Chairman/Chairman & Managing Director of the Company, Whole time Functional Directors and other Directors.

Ministry of Railways vide its letter No. 2004/PL/49/4 dated March 9, 2022 has appointed Shri Raj Kumar Mangla, AM(PU), as part time Government Nominee Director on the Board of RITES Limited. The Board of Directors in their meeting held on March 14, 2022, has appointed Shri Raj Kumar Mangla as Additional Director (Government Nominee) of the Company with effect from March 14, 2022.

In accordance to Regulation 17 (1C) of SEBI (Listing Obligation and Disclosure Requirement) Regulation, 2015, the listed entity shall ensure that approval of shareholders for appointment of a person on the Board of Directors is taken at the next general meeting or within a time period of three months from the date of appointment, whichever is earlier.

Therefore, approval of the shareholders is sought for regularization of the appointment of Shri Raj Kumar Mangla as Government Nominee Director on the same terms and conditions as determined by the Government of India. During his tenure as a Government Nominee Director in the Company, Shri Raj Kumar Mangla shall be liable to retire by rotation.

A brief profile of Shri Raj Kumar Mangla, in terms of SEBI (LODR) Regulations and Secretarial Standard-2, is annexed to this Postal Ballot Notice.

Shri Raj Kumar Mangla has declared that he is not debarred from being appointed as a Director by SEBI or any other authority; and that he is not disqualified from being appointed as a Director in terms of the provisions of the Act. Shri Raj Kumar Mangla is not related to any Director or Key Managerial Personnel of the Company.

In view of the above, it is proposed to obtain the approval of shareholders for appointment of Shri Raj Kumar Mangla, as Government Nominee Director on the Board of Directors of the Company, by passing Ordinary Resolution set out at Item no. 1 of this Postal Ballot Notice.

Shri Raj Kumar Mangla does not hold any share in RITES Limited.

Except Shri Raj Kumar Mangla, none of the Directors and Key Managerial Personnel of the Company or their relatives is concerned or interested in the resolution financially or otherwise, in passing of the said Ordinary Resolution, except to the extent of their shareholding in the Company.

The Board of Directors of your Company recommends passing of the resolution as set out at Item No. 1 of this postal ballot as an Ordinary Resolution.
