Sub: Disclosure under Regulation 30 - Revision in Credit Rating

Ref: "Vodafone Idea Limited" (IDEA / 532822)

Vodafone India Limited (VoIL) and Vodafone Mobile Services Limited (VMSL) which merged into the Company with effect from August 31, 2018 had credit ratings issued by India Ratings and Research (Ind-Ra) on VMSL's Non-Convertible Debentures of Rs. 6,000 crores. These ratings stand migrated to the Company i.e. Vodafone Idea Limited, consequent to amalgamation of VoIL and VMSL with the Company.
