दिल्ली खुलने के बाद कोरोना के मामलों में सबसे बड़ा उछाल दर्ज किया गया है। मंगलवार को दिल्ली में गतिविधियों के खुलने के बाद एक ही दिन में 534 मामले दर्ज किए गए। दिल्ली सरकार के आंकड़े के मुताबिक अब तक यह बीमारी 176 लोगों की दिल्ली में जान ले चुकी है। अब तक कुल 11088 मामले सामने आ चुके हैं और 5192 ठीक होकर अपने घर जा चुके हैं।

दिल्ली के कुल 50 से कम आयु के सबसे अधिक मामले है। अब तक ऐसे कुल 7813 लोगों को कोरोना ने अपना शिकार बनाया है। ऐसे

मरीज 11 हजार के पार, सील क्षेत्र हुए 69

दिल्ली में लगातार सामने आ रहे कोरोना संक्रमण के मामलों के बीच सील क्षेत्र की संख्या कम हो रही है। आज दिल्ली सरकार ने दक्षिणी दिल्ली में दो नए क्षेत्रों को एक तय समय के लिए सील कर दिया है। अब दिल्ली में कोरोना मरीजों को कुल आंकड़ा 11088 है और सील क्षेत्र की संख्या 69 है। इन क्षेत्रों की संख्या में तेजी से गिरावट आई है। जबकि इस समय 2358 लोग घर में एकांतवास में रखे गए है और सरकार कुल 1.5 लाख कोरोना जांच करा चुकी है। इस समय अस्पताल, कोरोना केंद्र समेत अन्य जगहों पर भी संक्रमण के मरीजों को रखा गया है।

बसों में 20 से अधिक यात्री नहीं बैठेंगे। यदि ऐसा होता है तो बस चालक, परिचालक व मार्शल के खिलाफ कार्यवाही होगी। बुधवार परिवहन मंत्री कैलाश गहलोत ने इस बाबत आदेश जारी किए हैं। उन्होंने कहा कि परिवहन सेवा के वाहन चालकों को इन आदेशों का सख्ती से पालन करना होगा। यदि किसी बस में 20 से अधिक यात्री बैठ जाते हैं, तो चालक बस नहीं चलाएगा।

चालक, परिचालक और मार्शल अतिरिक्त सवारी से नीचे उतरने के लिए अनुरोध करेंगे और फिर भी वे नहीं नीचे उतरते हैं, तो पुलिस की मदद ली जाएगी। मंत्री ने उम्मीद जताई कि धीरे-धीरे सड़क पर डीटीसी और क्लस्टर की सभी बसें उतर जाएंगी। कल करीब 3400 बसें सड़कों पर उतारी गई थीं। अगले एक-दो दिन में परिवहन सेवा समान्य हो जाएगी।

के बाद आने वाले यात्री नीचे नहीं उतरते हैं. तो 100 नंबर पर कॉल कर पुलिस को बुलाने का निर्देश दिया गया है। जब तक वे नहीं उतरते हैं, तब तक बस नहीं चलाएंगे। दिल्ली सरकार बार-बार निर्देश दे रही है कि कार में दो सवारी और बाइक पर सिर्फ एक व्यक्ति चल सकता है। इसमें लोगों का भी सहयोग बहत जरूरी है।

आनंद विहार व आसपास में नहीं हुए हालात सामान्य

पलयान कर रहे लोगों का आनंद विहार व आसपास के इलाकों में पलायन जारी है। बुधवार को पारा अधिक होने की वजह से आसपास के बस स्टॉप, मेट्रो के खंभे और बड़े पेड़ों की छांव में परिवार बैठे नजर आए। बस की संख्या कम थी और ऑटों में सवारी ले जाने की पाबंदी थी। इस वजह से यात्री अधिक परेशान दिखे। साथ ही कई निजी गाडियां भी इन मार्ग पर नजर आई जो पैसा लेकर लोगों को ले जाने का काम कर रहे थे।

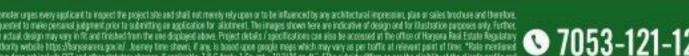




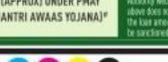
