Terrorism charges levelled against teenager in Sydney stabbings
Sydney: A 16-year-old boy accused of stabbing two Christian clerics during a Sydney church service has been charged by police with terrorism offenses. Authorities said the stabbing was declared a terrorist act because of the teenager's suspected religious motivation and that the boy travelled up to 90 minutes from his home to the Christ the Good Shepherd Church. The teen spoke in Arabic about the Prophet Muhammad being insulted after he stabbed Bishop Mar Mari Emmanuel and the Rev. Isaac Royal.



Israel gave US last-minute warning of attack on Iran

G7 session changed at the eleventh hour to address the suspected attack

The United States told the Group of Seven foreign ministers on Friday that it received "last minute" information from Israel about a drone action in Iran, Italy's foreign minister said.

Italian Foreign Minister Antonio Tajani, who chaired the meeting of ministers of industrialised countries, said the United States provided the information at a Friday morning session that was changed at the last minute to address the suspected attack.

Tajani said the US informed the G7 ministers that it had been "informed at the last minute" by Israel about the drones. "But there was no sharing of the attack by the US. It was mere information." Early Friday, Iran fired air defences at a major air base and a nuclear site near the central city of Isfahan af-

ter spotting drones, part of an apparent Israeli attack in retaliation for Tehran's unprecedented drone-and-missile assault on the country last weekend.

In a communique following the three-day meeting, the ministers urged the parties "to prevent further esca-

lation." The statement pledged support for Israel's security and condemned "in the strongest terms" what the foreign ministers described as Iran's "unprecedented attack against Israel of April 13-14."

Man held at Paris Iranian consulate

Police said Friday they detained a man at the Iranian consulate in Paris after responding to a report of a suspicious man possibly carrying a grenade and explosives vest, but they did not immediately confirm finding any weapon. A Paris police official told that officers were verifying the man's identity and trying to determine whether he had weapons. The official was speaking on condition of anonymity because he was not allowed to be publicly named under police policy. The official said the man was spotted around 11 a.m. (0900 GMT) on Friday and that police launched a special operation as soon as they were alerted.

No Air India Tel Aviv flights

A mid-escalating tensions in the Middle East, Air India announced to suspend flights to and from Tel Aviv until April 30, assuring the safety of their customers and crew members. Sharing on their social media platform X, Air India stated, "Our flights to and from Tel Aviv will remain suspended until 30th April 2024."



Xi launches new wing to fight cyber wars

Beijing: Chinese President Xi Jinping on Friday launched an Information Support Force, a new wing of the People's Liberation Army, which he said will be a strategic branch and a key pillar of the world's largest military. Xi, who also heads the Central Military Commission (CMC), the overall high command of the Chinese military, besides heading the ruling Communist Party of China (CPC) and the Presidency, said that the establishment of the Information Support Force (ISF) is a major decision made by the CPC and the CMC in light of the overall need of building a strong military. The Information Support Force (ISF) was regarded as the revised version of the PLA's Strategic Support Force (SSF), established in 2015 by the Chinese military to deal with the space, cyber, political and electronic warfare to fight what was described as informationised wars.

Dubai urges flyers not to crowd airport

Abu Dhabi: Dubai Airports urged passengers not to come to the airport unless their flight has been confirmed and recommended arriving only two hours before their scheduled departure. Emirates has also decided to suspend check-in for all customers across its network travelling with onward connections through Dubai, until 23:59 GMT on April 19. This is to support operations recovery from the recent bad weather at its Dubai hub. In a statement, Emirates said that passengers already in Dubai and in transit will continue to be processed for their flights.

3 dead amid heavy flooding in UAE

Dubai: Three people have died in the United Arab Emirates as a result of heavy flooding caused by record-setting rains this week, officials said Friday. A statement by the Philippine's Department of Migrant Workers said two women suffocated inside their vehicle during the flooding, while a man died when his vehicle fell into a sinkhole. The exact number of deaths caused by the storm is not yet known as UAE officials have not released any information.
