ITEM NO.2

This Explanatory Statement is provided though strictly not required as per Section 102 of the Act.

Mr.M.R. Gautham and his relatives may be deemed to be interested in the Ordinary Resolution about his reappointment as set out in Item No. 2 of the Notice.

ITEM NO.3

This Explanatory Statement is provided though strictly not required as per Section 102 of the Act.

Mrs.M.Sasikala and her relatives may be deemed to be interested in the Ordinary Resolution about her reappointment as set out in Item No. 3 of the Notice.

ITEM NO. 4

Based on the recommendation of the Nomination and Remuneration Committee, the Board of Directors at their meeting held on May 21, 2021 had re-appointed Mr.E.V.Muthukumara Ramalingam as Managing Director for 3 year period.

Based on the recommendation of the Board of Directors, Members at 31st Annual General Meeting of the Company held on the 23rd day of December, 2021 had approved the continuation of the re-appointment of Mr.E.V.Muthukumara Ramalingam as Managing Director upon the attainment of 70 years of age, for three years commenced from May 21, 2021 without any remuneration, not liable to retire by rotation.

By the provisions of Section 203 and Schedule V of the Companies Act, 2013 (the 'Act'), a person who has attained the age of 70 years can be appointed/re-appointed as Managing Director only by passing a special resolution, in which case, the explanatory statement annexed to the notice for such motion shall indicate the justification for appointing such person. The present terms of re-appointment of Mr.E.V.Muthukumara Ramalingam are expiring on 20th May 2024.

Considering his knowledge of various aspects relating to the Company's affairs and long business experience and in terms of the provisions of the Act and the Articles of Association of the Company, the Board of Directors of the Company at its meeting held on 14th August 2023 and on the recommendation of the Nomination and Remuneration Committee approved the re-appointment of Mr.E.V.Muthukumara Ramalingam as Managing Director (KMP) of the Company subject to the approval of members/shareholders of the Company in ensuing Annual General Meeting to be held on 27th September, 2023 as a Special Resolution for a period of three years from 21st May, 2024 to 20th May, 2027. Mr.E.V.Muthukumara Ramalingam is not disqualified from being re-appointed as a Director in terms of Section 164 of the Companies Act, 2013 and has given his consent to act as a Managing Director.

Mr.E.V.Muthukumara Ramalingam satisfies all the conditions set out in Part-I of Schedule V of the Act and also conditions set out under Section 196 (3) of the Act for being eligible for his reappointment.

Brief particulars of the terms of re-appointment of and remuneration payable to Mr.E.V.Muthukumara Ramalingam are as under:

- The term of the Managing Director's re-appointment is for three year period with effect from May 21, 2024. He shall not be liable to retire by rotation.
- The re-appointment of the Managing Director shall be without any remuneration. Further, no sitting fees shall be payable to the Managing Director during his tenure for attending any meeting of the Board or a committee thereof.
- The Managing Director shall be reimbursed for all the expenses incurred by him for travelling, boarding and lodging during his business trips conducted on behalf of the Company. These reimbursements of expenses will not be included in the calculation of the remuneration of the Managing Director.
- The Managing Director shall adhere to various policies, codes of conduct and staff rules of the Company as may be applicable by his office to discharge his official duties/powers as delegated by the Board from time to time.
- The Managing Director shall act the Articles of Association of the Company and shall abide by the provisions contained in Section 166 of the Act concerning duties of Directors.
- f. The office of the Managing Director may be terminated by the Company or the concerned Director by giving the other 3 (three) months prior notice in writing.

The brief resume of Mr. E.V. Muthukumara Ramalingam Managing Director, nature of his expertise in functional areas, disclosure of relationships between Directors, Directorships and Memberships of Committees of the Board of Listed entities and shareholding as required under Regulation 36(3) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended is set out below:

Mr. E.V. Muthukumara Ramalingam, aged 71 years, is a Commerce Graduate from Madras University. He has been a director ever since the incorporation of the Company. He started his career as a bus fleet operator and diversified into the finance business and later into the hospitality business.

He holds a Directorship in Shree Vallee Enterprises Pvt Ltd and Sarju International Ltd.

He holds 1,26,78,383 equity shares of the Company by himself, representing 39.66% of total shareholding and 1,29,03,351 equity shares held by his immediate relatives, representing 40.37% of the shareholding of the Company.

Since Mr.E.V.Muthukumara Ramalingam as Managing Director has already attained the age of 70 years, a special resolution, per proviso to Section 196 (3)(a) of the Act, is included in the notice seeking approval of the shareholders for the re-appointment of Mr.E.V.Muthukumara Ramalingam as Managing Director of the Company without remuneration.

The Board believes that the re-appointment of Mr.E.V.Muthukumara Ramalingam as Managing Director would be in the interest of the Company and it is desirable to continue to avail services of Mr.E.V.Muthukumara Ramalingam, Managing Director due to his extensive experience regardless of his age. Accordingly, the Board recommends the resolution about the re-appointment of Mr.E.V.Muthukumara Ramalingam Managing Director, for approval by the shareholders of the Company.

The above explanatory statement (together with Annexure thereto) shall be construed to be memorandum setting out the terms of the re-appointment as specified under Section 190 of the Companies Act, 2013 and all the material documents as referred above will be available for inspection at the Registered office of the Company by any Member of the Company without any fee during normal business hours on working days from the date of dispatch of the notice up to the last date of meeting.

Mr.E.V.Muthukumara Ramalingam is concerned or interested in this resolution as it relates to his re-appointment, Mr.M.R.Gautham, Executive Director and Mrs.M.Sasikala, Director being related to Mr.E.V.Muthukumara Ramalingam & their respective relatives may be deemed to be concerned or interested in the resolution. None of the other Directors, Key Managerial Personnel or their respective relatives is concerned or interested, financial or otherwise in the Resolution.

The Board recommends the Special Resolution set out in Item No.4 of the Special Business of the Notice for approval by the shareholders.

ITEM NO.5

The main objects are proposed to be altered as the Company looks towards widening the sphere of its main business and activities to cover new and emerging areas of business. It is also proposed to alter the main objects by including various modes of monetizing like leasing, letting out, giving on leave & license and partnerships etc. the idle assets such as land and buildings, which are not expected to be used for the business of the Company in the foreseeable future, to include the income / share of profits from these as part of the operating income of the Company. In purview of the above, your directors are considering leasing out the immovable properties and other properties as mentioned in the resolution till the sale of the Company's assets takes place.

In view of the said requirements, the Objects Clause is proposed to be amended as follows:

- Sub-clause numbered 7 of the existing Part A (main objects) are proposed to be replaced with new object which will cover an expanded scope of activities to be pursued by the Company to actively monetize its idle assets.
- One new clause numbered 8 will be added to the existing Part A (main objects) to enable the Company to widen the scope of its business activities.

The alteration of objects clause of the Memorandum of Association is an item required to be transacted by means of postal ballot under the provisions of section 110 of the Companies Act, 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014. However, in terms of the proviso to section 110 of the Companies Act, 2013 introduced as per the Companies (Amendment) Act, 2017, read with Rules 20 and 22 of the Companies (Companies Management and Administration) Rules, 2014 including any statutory modifications and amendments thereto, approval of shareholders for any item of business required to be transacted through postal ballot may be transacted at a general meeting by a company which is required to provide the facility of voting by electronic means to its shareholders. The Company, being a listed Company is required to provide the facility of voting by electronic means to its shareholders and hence, may obtain the approval of its shareholders to the alteration of the objects clause of the Memorandum of Association at the Annual General Meeting. The Board of Directors vide its resolution dated 23rd August 2023 has accorded its approval to the proposed alteration of the Memorandum of Association as aforesaid.

In terms of Sections 4 and 13 of the Act, the consent of the Members by way of a Special Resolution is required for alteration in the objects clause of the Memorandum of Association of the Company.

Copies of the existing and amended Memorandum of Association will be available for inspection by shareholders during business hours at the registered office of the Company for 21 days before the Annual General Meeting and can also be viewed on the Company's website at www.velanhotels.com.

None of the Directors, Key Managerial Personnel or their relatives is in any way concerned or interested, financially or otherwise in this resolution.

The Board recommends the special resolutions set out at the item no. 5 of the Notice for member's approval of the Company.

ITEM NO.6

Members may be aware that the Company's account was classified as NPA by Allahabad Bank and Andhra Bank during March 2014 and May 2014 respectively. During March 2017, the entire debts of the Company alongwith all underlying security interest, all rights, title & benefits were assigned to M/s.RARE Asset Reconstruction Limited (RARE ARC) (previously known as Raytheon Asset Reconstruction Company) under the applicable provisions of the SARFAESI Act by the said bankers.

By the said assignment, Hotel property along-with Maintenance Area Land at Tirupur have been in symbolic possession of or mortgage with RARE ARC under provisions of the SARFAESI Act and rules framed thereunder. After payment of substantial amount of dues to RARE ARC, other properties i.e. Multiplex Land (part) and convention centre land came out of the mortgage/hypothecation and hence, they are now free-hold properties and free from any encumbrance.

A major portion of the company's dues were settled with / remitted to RARE ARC from the proceeds of the sale of assets of the Company. To settle the balance outstanding with the said ARC, the Company placed an enabling resolution before the public shareholders of the Company for their approval to monetize the assets of the Company via sale at the ensuing AGM. This enabling resolution is being proposed to give adequate flexibility and discretion to the Board to finalize the terms of the sale of the assets. The Company would give priority to sell the assets (non-core assets) as mentioned under SI.No.1, 2 and 4 of the proposed resolution and shall not sell the Hotel Property situated at Tirupur at the immediate future with a view to keep the Company 'a going concern' by way of leasing the said hotel property after identifying Lessee (s) at appropriate time in future.

Under Section 110(1) of the Companies (Amendment) Act, 2017 as notified on 9th February 2018, any item of business to be transacted through postal ballot may be transacted at a general meeting by a company subject to provide the facility to members to vote by electronic means under Section 108 of the Act. Hence, your company proposed to transact this resolution at the ensuing Annual General Meeting for which the Company is pleased to offer a remote e-voting facility as an alternative for its Shareholders to exercise their vote on resolutions proposed to be passed at the AGM by way of Ballot form which will enable the shareholders to cast their votes electronically, instead of physical ballot forms.

According to SEBI (Listing Obligations and Disclosure Requirements) (Second Amendment) Regulations. 2023 w.e.f 16th June 2023, the sale, lease or disposal of an undertaking/assets of the Company outside Scheme of Arrangement shall require prior approval of public shareholders only, by way of special resolution. However, this amendment shall come into force on the date of its publication in the Official Gazette to be issued by SEBI at a later date. Such a special resolution shall be acted upon only if the votes cast by the public shareholders in favour of the resolution exceed the votes cast by such public shareholders against the resolution.

However, the provisions of this regulation shall not be applicable where the sale, lease or otherwise disposal of the whole or substantially the whole of the undertaking of a listed entity is by virtue of a covenant covered under an agreement with a financial institution regulated by or registered with the Reserve Bank of India. In our case, the Hotel property alongwith the Maintenance Area Land situated at Tirupur have been in symbolic possession of the said RARE ARC under applicable provisions of the SARFAESI Act, 2002. As the said RARE ARC registered with the Reserve Bank of India (RBI) as a Securitization and Reconstruction company under the SARFAESI Act, 2002, the said regulation for sale of Hotel property plus the Maintenance Area Land may not apply to the Company. Although prior approval for the sale of Hotel property plus the Maintenance Area Land is not necessary in the purview of the above, it has been included in the resolution out of an abundance of caution. Sale of other free-hold properties owned by the Company shall in any way require prior approval of public shareholders of the Company.

Regulation 37A of SEBI (Listing Obligations and Disclosure Requirements), 2015 regarding the sale, lease or disposal of an undertaking outside Scheme of Arrangement has been inserted in SEBI (LODR) (Second Amendment) Regulations, 2023 and it shall come into force after SEBI notification. However, the Company is to take a pre-emptive measure that is likely not strictly necessary at the moment, the resolution is now placed before the public shareholders of the Company for their approval with the intention of not convening a General meeting again to seek further approval after this amended regulation comes into force.

The object of and commercial rationale for carrying out such sale / disposal of assets of the Company and use of proceeds arising there-from is to pay outstanding debts of the Company to RARE ARC.

None of the Directors, Key Managerial Personnel or their relatives is in any way concerned or interested, financially or otherwise in this resolution.

The Board recommends a special resolution set out at Item No.6 of the Notice for public shareholders' approval of the Company. (i.e. Shareholders other than those forming part of Promoter and Promoter Group and other related parties).

ITEM NO.7

According to the provisions of Section 188 of the Companies Act, 2013 ("the Act"), read with the Companies (Meetings of Board and its Powers) Rules, 2014 ('Rules'), the Company is required to obtain the consent of the Board of Directors and prior approval of the members by way of an ordinary resolution, in case certain transactions with related parties exceeds such sum as is specified in the said Rules. The aforesaid provisions are not applicable in respect of transactions that are in the ordinary course of business and on an arm's length basis.

However, according to Regulation 23 of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') as amended, prior approval of the members through ordinary resolution is required for all material related party transactions, even if they are entered into in the ordinary course of business and on arm's length basis.

For this purpose, a transaction is considered material, if the transaction / transactions to be entered into individually or taken together with previous transactions during a Financial Year exceed 10% of the annual consolidated turnover of the Company as per the last audited financial statements of the Company or R 1000 Crore whichever is lower.

All the Related Party Transactions entered into by the Company are on an arm's length basis and in the ordinary course of business and approval of the Audit Committee / Board is obtained, wherever required.

The transaction(s) entered into by the Company, together with the transactions to be entered into the related parties qualifies to be a Material Related Party transaction under SEBI – LODR Regulations.

Accordingly, the Company proposes to obtain approval of its Members for approving as also for ratifying to the Board for carrying out / continuing with the transactions with the related parties, as this proposed amount to RPT falls within the purview of the SEBI Listing Regulations and all these transactions in aggregate, are material RPT under the SEBI Listing Regulations.

All the related parties shall abstain from voting, irrespective of whether the entity or person is a party to the particular transaction or not, per Regulation 23(4) of SEBI (LODR).

The sale of assets / undertaking of the Company are an item required to be transacted through postal ballot under the provisions of section 110 of the Companies Act, 2013 read with Rules 20 and 22 of the Companies

(Management and Administration) Rules, 2014. However, this amendment shall come into force on the date of its publication in the Official Gazette of SEBI at a later date. Such a special resolution shall be acted upon only if the votes cast by the public shareholders in favour of the resolution exceed the votes cast by such public shareholders against the resolution.

However, the provisions of this regulation shall not be applicable where the sale, lease or otherwise disposal of the whole or substantially the whole of the undertaking of a listed entity is by virtue of a covenant covered under an agreement with a financial institution regulated by or registered with the Reserve Bank of India. Based on the recommendations of the Nomination and Remuneration Committee (Committee), the Board of Directors of the Company at its meeting held on 14th August, 2023, appointed Mr.Muralidharan Subramanyam (DIN:03552399) as an Additional Director of the Company in the capacity of Independent Director for a term of 5 years with effect from 14th August, 2023 subject to the approval of the Members of the Company.

In terms of section 160 of the Companies Act, 2013, the Board Governance, Nomination and Remuneration Committee and the Board have recommended the appointment of Mr.Muralidharan Subramanyam as an Independent Director under the provisions of Sections 149 and 152 of the Companies Act, 2013.

In terms of Section 161(1) of the Act, Mr. Muralidharan Subramanyam holds office only up to the date of the forthcoming AGM but is eligible for appointment as a Director. A notice under Section 160(1) of the Act has been received from a Member signifying its intention to propose the appointment of Mr.Muralidharan Subramanyam as Non-Executive Independent Director, not liable to retire by rotation.

The Company has received a declaration from Mr. Muralidharan Subramanyam confirming that he meets the criteria of independence under the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Further, the Company has also received Mr.Muralidharan Subramanyam's consent to act as a Director in terms of section 152 of the Companies Act, 2013 and a declaration that he is not disqualified from being appointed as a Director in terms of Section 164 of the Companies Act, 2013.

In the opinion of the Board, Mr.Muralidharan Subramanyam fulfils the conditions specified in the Companies Act, 2013 and rules made there-under and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, for his appointment as an Independent Director of the Company and he is independent of the management. Considering Mr.Muralidharan Subramanyam's knowledge and experience, the Board of Directors believes that it would be in the interest of the Company to appoint him as an Independent Director for five years with effect from August 14, 2023.

Mr. Muralidharan does not hold any equity shares in the Company.

Considering the experience of Mr.Muralidharan Subramanyam, the Board recommends the Resolution at Item No. 12 of the accompanying Notice, for the approval of the Members by way of a Special Resolution.

OPERATIONAL REVIEW:

The Company suspended all the revenue-generating operations w.e.f. 24 March 2020 due to COVID-19 and has not carried out any business activities during the year as well, resulting in, the entire year being completely washed out.

During the year under consideration, the gross receipts of your company stood Rs.2.30 Lacs from Rs.Nil logged in the previous year. Profit / (Loss) before Interest, Depreciation and Taxation was Rs.(450.72) lacs against Rs. (149.55) Lacs recorded in the previous year. Similarly, the Profit / (Loss) after Tax for the year ended March 31, 2023 stood at (Rs.1849.17) lacs as against profit of Rs.937.72 lacs registered in the previous year.

STATE OF THE COMPANY'S AFFAIRS

During the year under review, the Company did not make any progress as the operations at the Company were halted since March, 2020.

As part of the OTS offer, RARE ARC gave its Letter of NoC on 28/10/2021 wherein they conveyed their approbation / no objection for the release of Plant & Machinery from the hypothecation, lying at Biomass based Renewable energy plant situated at Tirupur, Tamilnadu on the payment of the realization amount not less than Rs.4.50 Crores. The Company, however, has realized and scrapped the plant and machinery for the value of Rs.3.00 Crore only against the approbatory value of Rs.4.50 Crore due to the negative trend in demand for scrap that was supported by the decline in global steel production. This has resulted in a total realization loss of



Rs.1404.55 lakhs incurred by the Company from such scrap sales. These entire sale proceeds were remitted / paid to RARE ARC towards settlement, per OTS offer.

In June, 2022, the Company sold / disposed of the land area of the said energy plant for a total consideration of Rs.7.30 Crore. From such a sale, the Company incurred a realization loss of Rs.175.38 lakhs. To comply with obligations under the OTS offer, the Company has availed of a loan of Rs. 11.30 crore from the Managing Director of the Company. Out of both the sale consideration and unsecured loan amounting to Rs.18.60 Crore, a sum of Rs.16.30 Crore was paid / remitted to RARE ARC and the balance amount of Rs.2.30 Crore was used for repayment of part of the dues to sundry creditors and statutory dues as well. Upon remittance / payment of part of the dues to RARE ARC, they released the mortgage on the Multiplex Area Land (part), Convention Centre properties which had been in mortgage with RARE ARC. On releasing the mortgage, the said properties are freehold now and free from any encumbrance. Only the Hotel property and the Maintenance area land situated at Tirupur have been in mortgage with RARE ARC.

As part of ongoing negotiations and forming part of the "OTS offer" with RARE ARC, the Company is obliged to settle its dues to the said RARE ARC; the Company has placed the following resolutions before members of the Company for their approval:

- For alteration of the object clause of the Memorandum of Association by replacing it with a new object which will cover an expanded scope of activities to be pursued by the Company to actively monetize its idle assets to generate stable revenue.
- b. The proposed sale of assets / undertaking of the Company to prospective buyer(s) including the related parties.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

INDUSTRY STRUCTURE AND DEVELOPMENTS:

It is widely acknowledged that the tourist and hospitality sector, which encompasses travel and hospitality services like hotels and restaurants, is a development agent, a catalyst for socio- economic growth, and a significant source of foreign exchange gains in many countries. India's rich and exquisite history, culture, and diversity are showcased through tourism while also providing significant economic benefits. The consistent efforts of the central and the state governments have helped the tourism industry & hospitality services to recover from the COVID-19 pandemic shock and operate at the pre-pandemic level.

India being one the most popular travel destinations across the globe has resulted in the Indian tourism and hospitality industry emerging as one of the key drivers of growth in the services sector in India. The tourism industry in India has significant potential considering that Tourism is an important source of foreign exchange in India similar to many other countries.

The tourism industry is showing good signs of revival after the COVID-19 Pandemic. According to the latest data released by the Bureau of Immigration, India received 6.19 million foreign tourist arrivals (FTAS) during CY 2022 compared with 1.52 million during the same period of 2021. There were 10.93 million FTAS in India during the pre-pandemic year 2019. In 2022, the FTA was 6.19 million. This is 56 percent of pre-covid levels.

The foreign exchange earnings (FEES) have risen to Rs.11.34-lakh crore from Rs.65,000 crore the previous year, compared with 2021. This was a 106 percent hike. However, it is yet to reach pre-COVID levels of Rs.2.11 lakh crore.

B. OPPORTUNITIES

With a total area of 3,287,263 sq. km extending from the snow-covered Himalayan heights to the tropical rain forests of the south, India has a rich cultural and historical heritage, variety in ecology, terrains and places of natural beauty spread across the country. This provides a significant opportunity to fully exploit the potential of the tourism sector.

To boost visitor arrival, the Tourism Ministry has declared "Incredible India! Visit India Year 2023". The Indian Government has realized the country's potential in the tourism industry and has taken several steps to make India a global tourism hub. The government has now launched the "Dekho Apna Desh" initiative intending to create awareness among the citizens about the rich heritage and culture of the country and encourages citizens to travel within the country. The ministry has also introduced e-Visa for five subcategories i.e. e-Tourist visa, e-Business visa, e-Medical visa, e-Medical Attendant visa and e-Conference visa for nationals of 166 countries,

In Union Budget 2023-24, US\$ 290.64 million was allocated to Ministry of Tourism as the sector holds huge opportunities for jobs and entrepreneurship for youth in particular and to take promotion of tourism on mission mode, with active participation of states, convergence of government programmes and publicprivate partnerships.

India is the most digitally advanced traveller nation in terms of digital tools being used for planning, booking, and experiencing a journey. India's rising middle class and increasing disposable income have supported the growth of domestic and outbound tourism.



The Ministry of Tourism has partnered with the Quality Council of India (QCI), to assist the Hospitality Industry in their preparedness to continue operations safely and mitigate risks arising out of the COVID-19 pandemic through an initiative called SAATHI (System for Assessment, Awareness and Training for Hospitality Industry).

D. THREATS, RISKS AND CONCERNS:

The Hotel industry faces risk from the volatile socio-political environment in the local area.

The Hotel revenue is entirely dependent on the performance of Textile and Readymade Garments in Tirupur City. Tirupur City has approximately 60% of India's garments exports to key markets such as the US, European Union and UK. The US and European Union are still struggling with the high cost of interest / funding and increased inflation rate. In 2022, the US and EU annual inflation reached the highest level ever. Due to this, customers are spending less on non-essential items such as leisure Travel and textile items. Inflation impacting consumption economics and delicate geopolitics continue to mask the growth potential of the industry.

E. OUTLOOK:

India took over the presidency of G-20 in December. During India's year-long leadership of the block of countries that account for more than 80 per cent of world GDP, 75 per cent of global trade, and 60 per cent of the global population, the country to host a series of events and meetings.

G20 meetings are being held at 55 destinations across the country. Infrastructure at these cities is being augmented and upgraded for the G20 meetings. It is estimated that in 2023, more than 200 meetings involving officials and civil society from these countries will be organized in India across 50 cities. As many as 30 heads of state and government from the G20 nations, and those invited, are expected to participate in the summit. From such events, it is expected that inbound travel, MICE and in-person meetings, which had been subdued last year, would witness significant growth, which will further strengthen the path to healthy income of the Industry.

It is believed that the G20 will add to the high performance in FY23-24 of the industry, which is expected to grow at a minimum of 15 per cent this year and then at a CAGR of 10 per cent over the next decade.

a. Details of Audit Qualification:

i) Going Concern

We draw attention to Note No. 6 of the attached Financial Results for the year ended 31st March 2023. The Company's borrowings were taken over by M/s. RARE Asset Reconstruction Company Limited ("ARC") commencing from April 1, 2017 and out of the final One-time settlement amount of Rs. 97.32 crores agreed with the ARC, the company has made a payment of Rs. 59.30 cr. from the sale proceeds of Shopping Mall, part of Multiplex properties, Hotel at Coonoor and sale of power plant assets. In addition the management has infused a sum of Rs. 11.30 cr. as unsecured loan. The company intends to repay the balance to the ARC from the sale of other assets of the Company.

Further, We draw attention to Note No. 4, the Company having suspended all business operations and with no revenue being generated, the ability of the Company to repay its debts depends on the quantum of realisation from the sale of Assets, there exists a concern on the ability of the Company continuing as a Going Concern.

ii) Pending Confirmation of balance of Outstanding Debt:

Due to non-availability of confirmations in respect of loan taken over by ARC. In the absence of such confirmations, any provisions to be made for the variations in carrying amounts of outstanding balance of debt, cannot be quantified as well as the quantum of adjustment if any, required to be made remains unascertained.

iii) Impairment of Assets

The test for the impairment of the assets tied to the borrowings have not been carried out as only a portion of the assets have been sold as at the year end. With the other assets still in the possession of the



Company, impairment, if any, shall be quantifiable only on completion of the sale of the assets of the Company and extinguishment of the Debt. Therefore no loss is recognised on account of potential impairment.

iv) Delays in remittance of statutory dues:

There has been a significant delay in the remittance of Tax Deducted at Source, Goods and Service Tax, Value Added tax, Service Tax, Provident Fund and Employees' State Insurance to appropriate authorities. There were no amount outstanding pertaining to the accounting year 2022-23.

The Company's account was categorized as NPA by Allahabad Bank and Andhara Bank during the year 2014. In April, 2017, the said Banks assigned the entire debts of the Company alongwith all underlying security interest, all rights, title & benefits to M/s.RARE Asset Reconstruction Limited (previously known as Raytheon Asset Reconstruction Private Limited) under the applicable provisions of the SARFAESI Act. The Company opted for One-Time Settlement offer with the said ARC and obtained in-principle approval from them during March, 2021 and the final approval of OTS has now been received.

As per terms of in-priniple approval, the company has already paid Rs.30 crores on 30th March, 2021 from the proceeds of sale of Shopping Mall and part of Multiplex properties and paid Rs.10 crore from the proceeds of sale of Hotel at Coonoor.

During the year the company has repaid Rs.3 Crore from Sale of scrapped power plant and machinery and repaid Rs. 16.30 Crore from sale of vacant land and from funds infused by the Managing Director of the company as unsecured loan.

The revenues of the Velan Greenfields Hotel Tirupur was severely impacted due to the ongoing Covid-19 Novel Corona Virus pandemic forcing the closure of operations. With this closure all revenue generating operations of the Company has been suspended. The company is exploring options of selling a part or all of its revenue generating assets to settle all liabilities. In view of the above, the Company's ability of continuing as a Going concern is dependent on the value that can be generated by the sale of assets and the surplus, if any, available subsequent to the settlement of all liabilities. In view of the uncertainty on the realisable values, the impairment to the value of assets is not ascertainable at this juncture.

As per the final OTS offer provided by the ARC and accepted by the Company, such communication has been considered for the confirmation of the Outstanding Debt.

The Company is taking necessary steps to regularise the Statutory Dues. During the year, the company has paid dues relating to Provident Fund, Sales Tax and Tax Deducted at sources for Earlier Years amounting to Rs.27.95 Lacs.

Management is unable to estimate the impact on the above audit qualification. Reason is for same is stated below.

With the other assets still in the possession of the Company, impairment, if any, shall be quantifiable only on completion of the sale of the assets of the Company and extinguishment of the Debt, therefore no loss is recognised on account of potential impairment of Fixed Assets tied to the borrowings.
- b) After COVID-19 pandemic, the business operation of the company has been forced to Closure; with this closure all revenue generating operations of the Company has been suspended. The company is exploring options of selling a part or all of its revenue generating assets to settle all liabilities including Statutory Liabilities. In view of the above, the Company's going Concern is affected.
- No Provision for Gratuity /Leave encashment has been considered during the period due to all the employees of the company except KMP have resigned and there are no eligible employees during the year under review.
- iii) Auditors' Comments on (i) or (ii) above:
 - In the opinion of the management and also due to uncertainty in realizable values of remaining Fixed Assets by the management, no loss is recognised on account of potential impairment of Fixed Assets.

We have audited the standalone financial statements of Velan Hotels Limited ("the Company"), which comprise the Balance Sheet as of March 31, 2023, and the Statement of Profit and Loss, the Statement of Changes in Equity and the Statement of Cash Flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

The Company intends to repay the balance to the ARC from the sale of other assets of the Company.

Further, we draw attention to Note No. 35, the Company having suspended all business operations and with no revenue being generated, the ability of the Company to repay its debts depends on the quantum of realisation from the sale of Assets, there exists a concern on the ability of the Company continuing as a Going Concern. In view of the above, our opinion is **Qualified**.

Other Matters

In view of the lockdown and travel restrictions due to the outbreak of COVID-19, wherever physical access was not possible, necessary records / reports / documents were verified through digital medium, email, etc. on a sample basis and were relied upon as audit evidence for carrying out the audit for the current year. This has been carried out based on the advisory on "Specific Considerations while conducting Distance Audit / Remote Audit / Online Audit under current Covid-19 situation" issued by the Auditing and Assurance Standards Board of ICAL.



We have been represented by the management that the data provided for our audit purposes is correct, complete and reliable and is directly generated by the accounting system of the Company without any further manual modifications. 1. The Company overview

Velan Hotels Limited is a Public Limited Company incorporated and domiciled in India. The Company is in the business of providing Hospitality Services including running restaurants with a bar. The Corporate Office of the Company is located at Kangayam Road, Tiruppur-641 604, Tamilnadu. The equity shares of the Company are listed on BSE Ltd.

2. Basis of preparation of financial statements

A) Statement of compliance and basis of preparation

The Standalone Financial Statements comply, in all material aspects, with Indian Accounting Standards ('Ind AS') notified under Section 133 of the Companies Act, 2013 ('the Act') read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and other relevant provisions of the Act.

These financial statements have been prepared in accordance with the Generally Accepted Accounting Principles in India ('Indian GAAP') to comply with the Accounting Standards specified under Section 133 of the Companies Act, 2013, read with Rule 7 of the Companies (Accounts) Rules, 2014 and the relevant provisions of the Companies Act, 2013. The financial statements have been prepared under the historical cost convention on an accrual basis, except for certain items that are measured at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether the price is directly observable or estimated using another valuation technique.

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in Schedule III to the Companies Act, 2013 and Ind-AS, based on the nature of products and the time between the acquisitions of assets or processing and their realisation in cash and cash accruals.

B) Basis of measurement

These financial statements have been prepared on a historical cost convention and an accrual basis except for the following material items which have been measured at fair value as required by relevant Ind-AS:-

- a) Derivative financial instruments;
- b) Financial instruments classified as fair value through other comprehensive income or fair value through profit or loss; and
- c) The defined benefit asset/(liability) is recognised as the present value of defined benefit obligation less the fair value of plan assets.

C) Use of estimates and judgment

The preparation of the financial statements in conformity with Ind-AS requires the management to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from those estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected. In particular, information about significant areas of estimation, uncertainty and critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements are included in the following notes:



- a) Impairment testing: Investments in subsidiaries, goodwill and intangible assets are tested for impairment at least annually and when events occur or changes in circumstances indicate that the recoverable amount of the asset or cash-generating units to which these pertain is less than its carrying value. The recoverable amount of cash-generating units is higher in value-in-use and fair value less cost to dispose. The calculation of value in use of a cash generating unit involves the use of significant estimates and assumptions which include turnover and earnings multiples, growth rates and net margins used to calculate projected future cash flows, risk-adjusted discount rate, and future economic and market conditions.
- b) Deferred taxes: Deferred tax is recorded on temporary differences between the tax bases of assets and liabilities and their carrying amounts, at the rates that have been enacted or substantively enacted at the reporting date. The ultimate realization of deferred tax assets is dependent upon the generation of future taxable profits during the periods in which those temporary differences and tax loss carry forwards become deductible. The Company considers the expected reversal of deferred tax liabilities and projected future taxable income in making this assessment. The amount of the deferred tax assets considered realizable, however, could be reduced in the near term if estimates of future taxable income during the carry-forward period are reduced.
- c) Defined benefit plans and compensated absences: The cost of the defined benefit plans, compensated absences and the present value of the defined benefit obligation are based on actuarial valuation using the projected unit credit method. An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, future salary increases and mortality rates. Due to the complexities involved in the valuation and its long-term nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each reporting date.

3. Significant Accounting Policies

- i) **Functional and presentation currency**: These financial statements are presented in Indian rupees, the national currency of India, which is the functional currency of the Company.
- ii) Foreign currency transactions and translation: Transactions in foreign currency are translated into functional currency using the exchange rates prevailing at the date of the transaction. Foreign exchange gains and losses resulting from the settlement of such transactions and the translation at the exchange rates prevailing at the reporting date of monetary assets and liabilities denominated in foreign currencies are recognized in the statement of profit and loss and reported within foreign exchange gains/(losses), net within results of operating activities. Gains/(losses) relating to translation or settlement of borrowings denominated in foreign currency are reported within finance expense. Nonmonetary assets and liabilities denominated in foreign currency and measured at historical cost are translated at the exchange rate prevalent at the date of transaction. Translation differences on nonmonetary financial assets measured at fair value at the reporting date.

iii) Equity

a) Share capital and share premium

The Authorized Share Capital of the Company as of March 31, 2023, March 31, 2022 and April 1, 2021 is Rs.50,00,00,000 divided into 5,00,00,000 equity shares of Rs.10/- each. The par value of the equity shares is recorded as share capital and the amount received in excess of par value is classified as share premium.

Every holder of the equity shares, as reflected in the records of the Company as of the date of the



shareholder's meeting shall have one vote in respect of each share held for all matters submitted to vote in the shareholder meeting.

Revaluation Reserve b)

Revaluation reserve amounting to Rs. 5,70,97,925 (March 31, 2022 Rs. 5,77,76,780 and April 1, 2021 Rs. 5,84,55,635 respectively) is not freely available for distribution.

Retained earnings c)

Retained earnings comprise the Company's undistributed earnings after taxes.

d) Other comprehensive income

Changes in the fair value of financial instruments measured at fair value through other comprehensive income and actuarial gains and losses on defined benefit plans are recognized in other comprehensive income (net of taxes), and presented within equity as other comprehensive income.

iv) Property, plant and equipment

Recognition and measurement a)

Property, plant and equipment are measured at cost less accumulated depreciation and impairment losses, if any. Cost includes expenditures directly attributable to the acquisition of the asset. General and specific borrowing costs directly attributable to the construction of a qualifying asset are capitalized as part of the cost.

b) **Depreciation**

The Company depreciates property, plant and equipment over the estimated useful life on a straight-line basis from the date the assets are available for use. Assets acquired under finance lease and leasehold improvements are amortized over the shorter estimated useful life of the asset or the related lease term. Term licenses are amortized over their respective contract term. Freehold land is not depreciated. The estimated useful life of assets is reviewed and where appropriate adjusted annually.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment. Subsequent expenditure relating to property, plant and equipment is capitalized only when it is probable that future economic benefits associated with these will flow to the Company and the cost of the item can be measured reliably.

The cost of property, plant and equipment not available for use as at each reporting date is disclosed under capital work-in-progress.

Intangible assets v)

Intangible assets acquired separately are measured at the cost of acquisition. Intangible assets acquired in a business combination are measured at fair value as of the date of acquisition. Following initial recognition, intangible assets are carried at cost less accumulated amortization and impairment losses, if any.



The amortization of an intangible asset with a finite useful life reflects the manner in which the economic benefit is expected to be generated. The estimated useful life of amortizable intangibles are reviewed and where appropriate are adjusted, annually.

vi) Leases

The determination of whether an arrangement is, or contains, a lease is based on the substance of the arrangement at the inception date. The arrangement is, or contains a lease if, fulfilment of the arrangement is dependent on the use of a specific asset or assets or the arrangement conveys a right to use the asset or assets, even if that right is not explicitly specified in an arrangement.

Arrangements where the Company is the lessee a)

Leases of property, plant and equipment, where the Company assumes substantially all the risks and rewards of ownership are classified as finance leases. Finance leases are capitalized at lower of the fair value of the leased property and the present value of the minimum lease payments. Lease payments are apportioned between the finance charge and the outstanding liability. The finance charge is allocated to periods during the lease term at a constant periodic rate of interest on the remaining balance of the liability.

Leases where the lessor retains substantially all the risks and rewards of ownership are classified as operating leases. Payments made under operating leases are recognized in the statement of profit and loss on a straight-line basis over the lease term.

b) Arrangements where the Company is the lessor

In certain arrangements, the Company recognizes revenue from the sale of products given under finance leases. The Company records gross finance receivables, unearned income and the estimated residual value of the leased equipment on consummation of such leases. Unearned income represents the excess of the gross finance lease receivable plus the estimated residual value over the sales price of the equipment. The Company recognizes unearned income as finance income over the lease term using the effective interest method.

vii) **Inventories**

Inventories are valued at lower cost and net realizable value, including necessary provision for obsolescence. Cost includes all direct costs and applicable overheads to bring the goods to the present location and condition.

viii) Impairment

Goodwill and intangible assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less the costs of disposal and value in use. To assess impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Nonfinancial assets other than goodwill that suffered impairment are reviewed for possible reversal of the impairment at the end of each reporting period.



ix) Employee benefits

a) Post-employment and pension plans

The Company participates in various employee benefit plans. These employment benefits are classified as either defined contribution plans or defined benefit plans.

Under a defined contribution plan, the Company's only obligation is to pay a fixed amount with no obligation to pay further contributions if the fund does not hold sufficient assets to pay all employee benefits. The related actuarial and investment risks fall on the employee.

The expenditure for defined contribution plans is recognized as an expense during the period when the employee provides service.

Under a defined benefit plan, the Company must provide agreed benefits to the employees. The related actuarial and investment risks fall on the Company. The present value of the defined benefit obligations is calculated by an independent actuary using the projected unit credit method. All actuarial gains or losses are immediately recognized in other comprehensive income, net of taxes and permanently excluded from profit or loss. Further, the profit or loss will no longer include an expected return on plan assets. Instead, net interest recognized in profit or loss is calculated by applying the discount rate used to measure the defined benefit obligation to the net defined benefit liability or asset. The actual return on the plan assets above or below the discount rate is recognized as part of the re-measurement of net defined liability or asset through other comprehensive income, net of taxes.

The Company has the following employee benefit plans:

A. Provident fund

Employees receive benefits from a provident fund, which is a defined benefit plan. The employer and employees each make periodic contributions to the plan. The contributions to the provident fund are charged to the statement of profit and loss for the year when the contributions are due.

B. Gratuity

In accordance with the Payment of Gratuity Act, 1972, applicable for Indian companies, the Company provides for a lump sum payment to eligible employees, at retirement or termination of employment based on the last drawn salary and years of employment with the Company. The Company's obligation in respect of the gratuity plan, which is a defined benefit plan, is provided for based on actuarial valuation using the projected unit credit method. The Company recognizes actuarial gains and losses in other comprehensive income, net of taxes.

b) Termination benefits

Termination benefits are expense when the Company can no longer withdraw the offer of those benefits.

c) Short-term benefits

Liabilities for wages and salaries, including non-monetary benefits that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.



d) Compensated absences

The employees of the Company are entitled to compensate absences. The employees can carry forward a portion of the unutilized accumulating compensated absences and utilize it in future periods or receive cash at retirement or termination of employment. The Company records an obligation for compensated absences in the period in which the employee renders the services that increase this entitlement. The Company measures the expected cost of compensated absences as the additional amount that the Company expects to pay as a result of the unused entitlement that has accumulated at the end of the reporting period. The Company recognizes accumulated compensated absences based on actuarial valuation using the projected unit credit method.

Non-accumulating compensated absences are recognized in the period in which the absences occur.

x) Provisions

Provisions for legal claims, service warranties, volume discounts and returns are recognised when the group has a present legal or constructive obligation as a result of past events, an outflow of resources will probably be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are several similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period.

xi) Revenue

Income from Guest Accommodation is recognised on a day-to-day basis after the Guest Checks into the hotel. The sale of food and beverages is recognised at the point of serving those items to the guest.

Revenues are shown net of sales tax, value added tax, service tax and Good and Service Tax.

xii) Borrowing cost

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period to get ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

Other borrowing costs are expensed in the period in which they are incurred.

xiii) Other income

Other income comprises interest income on deposits and dividend income.

- a) Interest income is recognized using the effective interest method.
- b) Dividend income is recognized when the right to receive payment is established.



xiv) Income tax

Income tax comprises current and deferred tax. Income tax expense is recognized in the statement of profit and loss except to the extent it relates to a business combination, or items directly recognized in equity or in other comprehensive income.

a) **Current income tax**

Current income tax for the current and prior periods is measured at the amount expected to be recovered from or paid to the taxation authorities based on the taxable income for the period. The tax rates and tax laws used to compute the current tax amount are those that are enacted or substantively enacted as of the reporting date and applicable for the period. The Company offsets current tax assets and current tax liabilities, where it has a legally enforceable right to set off the recognized amounts and where it intends either to settle on a net basis or to realize the asset and liability simultaneously.

Deferred income tax b)

Deferred income tax is recognized using the balance sheet approach. Deferred income tax assets and liabilities are recognized for deductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount in financial statements, except when the deferred income tax arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profits or loss at the time of the transaction.

Deferred income tax assets are recognized to the extent it is probable that taxable profit will be available against which the deductible temporary differences and the carry forward of unused tax credits and unused tax losses can be utilized. Deferred income tax liabilities are recognized for all taxable temporary differences except in respect of taxable temporary differences associated with investments in subsidiaries, associates and foreign branches where the timing of the reversal of the temporary difference can be controlled and, probably that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred income tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred income tax asset to be utilized. Deferred income tax assets and liabilities are measured at the tax rates that are expected to apply in the period when the asset is realized or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date.

The Company offsets deferred income tax assets and liabilities, where it has a legally enforceable right to offset current tax assets against current tax liabilities, and they relate to taxes levied by the same taxation authority on either the same taxable entity or on different taxable entities where there is an intention to settle the current tax liabilities and assets on a net basis or their tax assets and liabilities will be realized simultaneously.

Earnings per share xv)

Basic earnings per share are computed using the weighted average number of equity shares outstanding during the period adjusted for treasury shares held. Diluted earnings per share are computed using the weighted-average number of equity and dilutive equivalent shares outstanding during the period, using the treasury stock method for options and warrants, except where the results would be anti-dilutive.



4. Recent Indian Accounting Standard (Ind AS) pronouncements which are not yet effective

On March 31, 2023, the Ministry of Corporate Affairs (MCA) through notification notified the amendments to existing standards which are effective for annual periods beginning after 1st April 2023. Key amendments relating to the same where financial statements are required to comply are:

Amendments to Ind AS 12 Income Taxes— Deferred Tax related to Assets and Liabilities arising from a Single Transaction:

Under the amendments, an entity does not apply the initial recognition exemption for transactions that give rise to equal taxable and deductible temporary differences. Equal taxable and deductible temporary differences may arise on initial recognition of an asset and liability in a transaction that is not a business combination and affects neither accounting nor taxable profit. For example, this may arise upon recognition of a lease liability and the corresponding right-of-use asset applying Ind AS 116 Leases at the commencement date of a lease. The amendments should be applied to transactions that occur on or after the beginning of the earliest comparative period presented. In addition, at the beginning of the earliest comparative period presented, a deferred tax asset (provided that sufficient taxable profit is available) and a deferred tax liability should also be recognised for all deductible and taxable temporary differences associated with leases and decommissioning obligation

Amendments to Ind AS 1 Presentation of Financial Statements – Disclosure of Accounting Policies:

The amendments replace all instances of the term 'significant accounting policies' with 'material accounting policy information'. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general-purpose financial statements make based on those financial statements. The supporting paragraph in Ind-AS 1 is also amended to clarify that accounting policy information that relates to immaterial transactions, other events or conditions is immaterial and need not be disclosed. Accounting policy information may be material because of the nature of the related transactions, other events or conditions, even if the amounts are immaterial. However, not all accounting policy information relating to material transactions, other events or conditions is itself material.

Amendments to Ind AS 8 Accounting Policies, Changes in Accounting Estimates and Errors—Definition of Accounting Estimates:

The amendments replace the definition of a change in accounting estimates with a definition of accounting estimates. Under the new definition, accounting estimates are "monetary amounts in financial statements that are subject to measurement uncertainty". The amendments clarify the distinction between changes in accounting estimates and changes in accounting policies and the correction of errors. Also, they clarify how entities use measurement techniques and inputs to develop accounting estimates.

These amendments are not expected to have a significant impact on the Company's Standalone Financial Statements. This assessment is based on currently available information and may be subject to changes arising from further reasonable and supportable information being made available to the company when it adopts the respective standards.

Note No: 35 - sale of assets of Velan Esplanade Mall

During the year the company has scrapped the power plant and machinery for value of Rs. 3,00,00,000 and thereby has incurred a total loss of Rs.1404.55 Lakhs on account of such sale and the same has been classified under Exceptional items of financial statement. This entire sale proceeds has been paid to M/s.Rare Asset Reconstruction Limited (ARC) towards settlement.

Also sold vacant land for a total consideration of Rs.7,30,25,000/- and the managing director of the company has infused Rs.11,30,00,000/- by unsecured loan. Out of the total sum amounting to Rs. 18,60,25,000 a sum of Rs.16,30,00,000 was paid to M/s.Rare Asset Reconstruction Limited (ARC) and the balance Rs. 2,30,25,000 was used for repayment of part of the dues to Sundry Creditors and Statutory Dues. The company has incurred loss of Rs.175.38 lakhs on sale of this property and same has been classified under Exceptional items of above financial statement.

Note No: 36 - Asset Reconstruction Company

The Company's account was categorized as NPA by Allahabad Bank and Andhra Bank during the year 2014. In April, 2017, the said Banks assigned the entire debts of the Company alongwith all underlying security interest, all rights, title & benefits to M/s.RARE Asset Reconstruction Limited (previously known as Raytheon Asset Reconstruction Private Limited) under the applicable provisions of the SARFAESI Act. The Company opted for One-Time Settlement offer with the said ARC and obtained in-principle approval from them during March, 2021 and the final approval of OTS has now been received. As per terms of in-priniple approval, the initial payment of Rs.30 crores was already paid to the said ARC on 30th March, 2021 from the proceeds of sale of Shopping Mall and part of Multiplex properties.

During the year the company has scrapped the power plant and machinery for value of Rs. 3,00,00,000 and entire sale proceeds has been paid to M/s.Rare Asset Reconstruction Limited (ARC) towards settlement.

Also sold vacant land for a total consideration of Rs.7,30,25,000/- and the managing director of the company has infused Rs.11,30,00,000/- by unsecured loan. Out of the total sum amounting to Rs. 18,60,25,000 a sum of Rs.16,30,00,000 was paid to M/s.Rare Asset Reconstruction Limited (ARC)

Salient features of OTS offer approved by RARE ARC as follows:

1. Total OTS amount is agreed as Rs. 96.80 Cr payable by the Company to RARE ARC towards full and final settlement including Advisory and Consultancy fees payable in several tranches.



- 2. The Company shall pay a sum of Rs.1.00 Cr plus GST to RARE ARC towards Restructuring and Consultancy fees for arranging and identifying suitable investor / buyer for the secured assets. This sum of Rs.1 crore shall be adjusted in the next installment.

- 4. The entire OTS payment shall be paid on or before 31st March, 2023, failing which the proposed OTS shall stand invoked by RARE ARC without any further notice.
- 5. All expenses toward recovery, over and above the OTS amount, incurred and to be incurred by RARE ARC shall be reimbursed by the Company on actual basis.
- 6. The ARC shall agree to issue NOC / release charge / handover title deeds of the respective properties for sale to any prospective buyer in order to settle the liability.
- 7. The Company/guarantors shall not raise any further loans, whether secured / unsecured, till the settlement amount is paid.
- 8. On payment of entire OTS amount, RARE ARC shall realase the charge over the remaining securities / properties and personal guarantees of the promoters/directors of the company and shall issue no due certificate.
- 9. Both the Company and ARC shall arrange to withdraw all the cases filed against each other after payment of entires OTS amount.
 - In view of the above settlement The Company has remitted Rs.59.48 crores to RARE ARC as on 31st March, 2023 from the disposal / sale of assets of company as detailed note no. 35 of the financial statement.

Note: 37: Pending Litigations

The Company has filed an stay petition with Labour Court amounting to Rs. 5.99 lacs for payment of damages on late payment of Employees Provident Fund for the period from Oct 2015 to Mar 2018 as against the order passed by the Assisstant Provident Fund Commissioner.

The Company has filed an rectification for the outstanding demands raised by Income Tax Authorities for payment of Income Tax and Tax Deducted at Source and same is pending for processing. The above said demands are payable subject to pending rectification.

Note: 38: Segment Reporting

During this quarter, The Company has only one reportable business segment as it deals only in Operation and running of Hotels in terms of Ind AS 108 Operating Segment". Further, the Company operates only in one geographical segment India. All the assets of the Company are located in India. the Company monitors the operating results as one single segment for the purpose of making decisions about resource allocation and performance assessment. Accordingly, there are no separate reportable segments as per IND-AS 108, "Operating Segment" prescribed under Section 133 of the Companies Act, 2013 read with the Companies (Indian Accounting Standards) Rules, 2015, as amended.
