"We pay only 0.25 per cent commissions on (third-party)
payment gateway charges. Most companies do not pay more than 2percent, which is on the higher side. Gooogle, on the
same service, ischarging a $15-30$ per centshare," said Singh Google's billing policy, developers said, also gave the company access to every transaction made by customers along with other sensitive user data. "On top of that, they
(Google) have asked for audit rightson our books in our off ice. They can basically raid our office at any point and audit our books. By doing that, they are in direct conflict with the Digital Personal Data Protection Act, where we have to pro ide Google this data without the consent of users," he added that was removed by Google, said: "We have sought an immediate resolution,
