Dear Sir/ Madam,

We are in receipt of your email dated 06th April 2024 regarding delayed submission of proceeding of 26th Annual General Meeting of the Company held on 29th September 2023.

In this matter we want to explain that prior to amendments vide SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, the timeline for submission of proceeding of General Meetings was 24 hours following the AGM.

But after this SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 the timeline for submission of General Meeting Proceedings was reduced from 24 hours to 12 hours.

But at the time of submitting of AGM proceedings, we were under assumption that the timeline for submitting the proceedings of Annual General Meeting is still 24 hours and therefore we filed the AGM proceeding at 01:18:04 PM on 30th September 2023 as per old timeline.

This was happened due to oversight of recent amendment in timelines vide SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023.

We are a legal complaint Company in words and sprits as well. Further we assure you that such delays will not recur in the future.

We have now adjusted our internal processes to align with the SEBI Circular dated July 13, 2023, and we will meet the 12-hour disclosure requirement for any future AGMs.

BRIEF PROCEEDINGS OF THE 26TH ANNUAL GENERAL MEETING OF BONLON INDUSTRIES LIMITED HELD ON FRIDAY, 29TH DAY OF SEPTEMBER, 2023 AT 02:00 P.M THROUGH VIDEO CONFERENCING (VC)/OTHER AUDIO VISUAL MEANS (OAVM).

Mr. Naveen Kumar, Company Secretary and Compliance Officer of the Company, welcomed the Members present at the virtual AGM. Mr. Naveen Kumar informed that the 26th Annual General Meeting (AGM) being held video conferencing ("VC")/ other audio-visual means ("OAVM") in compliance with Circular(s) issued by the Regulators. Then he informed the shareholders about some instructions to be followed during the AGM. He has also informed that deemed venue of the meeting will be registered office and also gave information regarding question and answer session. He further informed that the remote e-voting facility to all the shareholders were provided from 26th September 2023 (09:00 A.M.) to 28th September 2023 (05:00 P.M.) on all resolutions set forth in the Notice of 26th Annual General Meeting. Then began his formal address to the shareholders.
