Sub: Record Date for Partial Redemption and Payment of pro-rata Dividend on Bonus Preference Shares

Notice is hereby given that, in accordance with Regulation 50 of the SEBI Listing Regulations and as per the terms of 6% Cumulative Redeemable Non-Convertible Preference Shares issued by the Company in 2014 (Bonus Preference Shares), the second tranche of redemption of the Original Value of the said Bonus Preference Shares (i.e. redemption of Rs 2/- per share) is due for redemption on March 5, 2019. Subsequent to the said redemption, the Nominal Value of the Bonus Preference Shares shall stand reduced from Rs 8/- to Rs 6/- per preference share on and from March 6, 2019.

The Bonus Preference Shareholders shall also be paid Preference Dividend @ 6% per annum on the redemption value of Rs 2 per share on a pro-rata basis for the period from April 1, 2018 to March 5, 2019 (both days inclusive).

Accordingly, as per Regulation 60 of SEBI Listing Regulations, the Company has fixed **Friday, March 1, 2019** as the Record date for determining the Bonus Preference Shareholders who would be eligible for payment of

- Partial redemption amount of Rs 2 per share on the existing Preference Shares of Rs 8/- each; and
- Pro-rata Preference Dividend calculated @ Re 0.11145 per Bonus Preference Share and paid after rounding off the said dividend amount to the nearest two decimals.
