Subject: <u>Revision in Benchmark Rates</u>

In terms of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we have to inform you that the Asset Liability Management Committee (ALCO) of the Bank has reviewed the Marginal Cost of funds based Lending Rate (MCLR) and Treasury Bills Linked Lending Rates (TBLR) and decided for revision in MCLR and TBLR across Tenors, as detailed below:

<u>MCLR</u>
