This is in reference with the provision of Regulation 30 Para A Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements), Regulation, 2015 read with SEBI Circular No. CIR/CFD/CMD/4/2015 dated 9th September, 2015, we wish to inform you that the Company has acquired 190000 Equity shares of M/s. Attribute Shares & Securities Private Limited on 31st March, 2021 at the consideration of Rs. 1,67,20,000/-and which is constituting 7.37% of the share capital of the Company.

Please note that previously, the Company was holding 34800 equity shares constituting 1.35% of shares & voting rights in the Company.
