**New Delhi:** Food company Kraft Heinz has inked a distribution partnership with Indo Nissin Foods after the divestment of its consumer brands business to Ahmedabad-based Zydus Wellness.

With this deal, Kraft Heinz's existing products like ketchup and new launches will be distributed through Indo Nissin, the Indian subsidiary of diversified Japanese food maker Nissin Food Products.

Indo Nissin owns the popular noodles brands Cup Noodles and Top Ramen. The company has a distribution network of 250,000 stores and the partnership will help expand business outreach, its managing director,

ET had reported in November last year that Kraft Heinz was in talks with potential distribution partners.

Kraft Heinz's managing director Sankalp Potbhare said the partnership will target multiple channels like retail, modern trade and e-commerce distribution.

Late last year, Kraft Heinz sold off its non-core brands such as Complan, Glucon-D, Nycil and Sampriti to Zydus Wellness and its parent Cadila Healthcare for ₹4,595 crore.

After the divestment, Kraft Heinz is only left with ketchup in India, though globally it is the world's fifth largest food and beverages company with over 200 brands including Heinz condiments, Bakers chocolate and Maxwell House coffee. Two years ago, Indo Nissin Foods had forged a similar distribution tie-up with breakfast cereal maker Bagrrys.
