Dear Sir/Mam

I Ekta Kumari, Practicing Company Secretary, of Patna have been appointed as the scrutinizer by the Board of Directors of M/s "Aditya Vision Limited" for the purpose of scrutinizing remote e-voting for postal ballot process in a fair and transparent manner and for the purpose of ascertaining the requisite majority on the remote e-voting for postal ballot carried out in accordance with the provisions of Sections 108 & 110 of the Companies Act, 2013 ('the Act') read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("Rules") and other applicable provisions of the Act and Rules made there under, Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the General Circular No.14/2020 dated April 8, 2020, Circular No.17 /2020 dated April 13, 2020, Circular No. 33/2020 dated September 28, 2020 and Circular No. 39, 2020 dated December 31, 2020 issued by the Ministry of Corporate Affairs, Government of India ("MCA Circulars") in respect of the Resolution as set out in the Postal Ballot Notice dated 03rd March, 2021.

My responsibility, as a Scrutinizer for the Postal Ballot through Remote E-voting process, is restricted to the preparation of the Scrutinizer's Report on the votes cast "in favour" or "against" the Resolution, of the Postal Ballot Notice dated 03rd March, 2021, based on the reports generated from the e-voting system provided by the Central Depository Services (India) Ltd ("CDSL") the Authorized Agency engaged by the Company for providing remote e-voting facilities.

Further, in addition to the above, I submit my report as under:

- 1. The Postal Ballot Notice dated 03rd March, 2021 along with necessary statement setting out the material facts under Section 102 of the Companies Act, 2013 were sent on Wednesday, 10th March, 2021 by the Company through electronic mail to those members whose names appeared in the Register of Members/ List of Beneficiaries as on Friday, 05th March, 2021 ("cut-off date") and who had registered their email ID with the Company / RTA / Depositories in compliance with the MCA Circulars. The Company has also placed the notice of the Postal Ballot on the website of the Company.
- The Shareholders of the Company holding shares as on the "Cut-off" date (i.e. on Friday, 05th March, 2021) were entitled to vote on the resolutions as set out in the Notice of Postal Ballot.
- The Company has published on Thursday, March 11, 2021 an advertisement about the dispatch of the Postal ballot Notice.
- I have monitored the process of electronic voting through the scrutinizer's secured link provided to me (http://www.evotingindia.com).
- 5. The remote e-voting period for the postal ballot commences from Thursday, 11th March, 2021 at 09:00 a.m. (IST) and ends on Friday, 09th April, 2021 at 05:00 p.m. (IST). During this period shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. Friday, 05th March, 2021 casted their vote electronically.
- After the closure of remote e-voting, I have unblocked the votes cast in the presence of two witnesses who are not in the employment of the Company.
