धर्मशाला: चंबा जिले की चुराह घाटी के उपमंडल मुख्यालय भंजराडू सड़क पर कलहेल गांव में बीते रोज देर रात एक कार ढांक से नीचे जा गिरी। इस हादसे में द्रबला निवासी युवक गुड्डू राम की मौके पर मौत हो गई जबकि उसका दूसरे साथी की हालत गंभीर बताई जा रही है। हादसे की जानकारी लोगों को सोमवार सुबह ही मिली। उसके बाद ग्रामीणों ने घायल को खाई से बाहर निकाला और अस्पताल पहुंचाया।
पशु चराने गई महिला का पैर फिसला, मौत
कुल्लू: उप तहसील सैंज की ग्राम पंचायत कनौन के जऊल गांव में पशु चराने गई एक महिला का पैर फिसलने और गहरी खाई में गिरने से मौत हो गई है। स्थानीय पंचायत प्रधान किरण देवी ने जानकारी देते हुए बताया कि डालावतु देवी गत दिन गांव के पास के जंगल में पशु चराने गई थी कि अचानक महिला का पैर फिसल गया जिस कारण वह 200 फुट नीचे गहरी खाई में गिरी और उसकी मौके पर ही मौत हो गई। उन्होंने बताया कि महिला देर शाम तक जब घर नहीं पहुंची तो परिवार वाले महिला को ढूंढने के लिए निकले लेकिन महिला का कोई पता नहीं चल सका। इसके बाद ग्रामीणों ने देर रात तक आसपास के स्थानों में महिला की तलाशी को लेकर अभियान चलाया और रात को जाकर महिला का शव नाले में मिला। ग्राम पंचायत की सूचना पर पुलिस मौके पहुंची तथा शव को अपने कब्जे में लेकर पोस्टमार्टम के लिए बंजार ले गई तथा पुलिस ने कागजी कारवाई पूरी कर शव परिवार जनों को सौंप दिया है।
