

# BRICS for settling Afghan situation in peaceful way

Calls for making Brics more productive

New Delhi, 9 September

The territory of Afghanistan must not be used to carry out terror attacks against other countries, the five-nation influential grouping BRICS said on Thursday and strongly called for combating terrorism in all its forms and manifestations, including the cross-border movement of terrorists.

The grouping held extensive deliberations on pressing issues, including the situation in Afghanistan at a virtual summit chaired by Prime Minister Narendra Modi, who cautioned against any complacency among BRICS members and called for making the grouping of five nations more productive in the next 15 years.

"... (it is important that) we do not become too self-satisfied and we must ensure that BRICS is even more result-oriented in the next 15 years," Modi said, while chairing the 13th BRICS Summit virtually.

The summit, hosted by India, was attended by Russian President Vladimir Putin, Chinese President Xi Jinping, South African President Cyril Ramaphosa,

and Brazil's Jair Bolsonaro. He said the grouping of Brazil-Russia-India-China-South Africa has become an influential voice of emerging economies of the world.

He said the grouping has also been useful for focusing on priorities of the developing nations.

Modi also highlighted that cooperation between the Customs departments of the five nations will make trade among these nations easier.

He disclosed that BRICS has adopted a counter-terrorism plan.

He said BRICS has created powerful institutions, such as the New Development Bank, Contingency Reserve Arrangement, and the Energy Research Cooperation Platform.

He said BRICS, under the

chairmanship of India, has organised 150 meetings and programmes, of which more than 20 were ministerial, despite the Covid-19 pandemic. Pointing out that efforts were made to expand the BRICS agenda, he said many firsts were achieved this year.

"It was for the first time that BRICS took a collective position on strengthening and reforming multilateral systems." He also said the first BRICS digital health conference was organised recently, which was an innovative step to improve access to health through technology.

Besides, water resources ministers will meet in November in the BRICS format, he said.

He said these initiatives will not only benefit citizens of the five nations, but will also

make BRICS relevant in the times to come.

He said with the agreement on remote sensing satellite constellation between space agencies of BRICS nations, a new chapter of cooperation has begun.

"There has also been a consensus with regards to starting a virtual BRICS Vaccination Research and Development Centre. The BRICS Alliance on green tourism is also another new initiative," he pointed out.

BRICS brings together five of the largest developing countries of the world, representing 41 per cent of the global population, 24 per cent of the global gross domestic product, and 16 per cent of the global trade.

India hosted the summit in its capacity as its chair.





## MSP HIKES NEED TO BE SUPPLEMENTED BY HIGHER YIELDS: EXPERTS

The Minimum Support Price (MSP) of rabi crops for the 2022-23 marketing season, which will start from April, was announced on Wednesday. The maximum rise was reserved for oilseeds and pulses, while the least increase was for cereals, in this case wheat. But some experts feel that just increasing the MSP without a rise in yields and without a big rise in procurement doesn't serve the purpose. "Increasing MSP is good but it has its own limitations as beyond a point it will start pinching the consumers. Therefore, MSP hikes need to be supplemented by rising yields which can happen through better seeds and better farming practices," said Bimal Kothari, vice-chairman of Indian Pulses and Grains Association (IPGA). Meanwhile, in the Rabi 2022-23 report, the CAP - which recommends the price - said the cost of production data for crops comes with a two-year lag, which makes projections difficult. Business Standard looks at the MSP hikes of main rabi crops in the last 10 years and their percentage rise compared to previous years.

## Karnal bears signs of being a Fort Knox for farmer activism

A day ago, the road to the mini secretariat in Karnal was impregnable - it was turned into a garrison with heavy deployment of police and paramilitary forces, as farmers thronged the street for a sit-in protest, days after a crackdown on those agitating against the farm laws. *Langars* serving food to protesters and security personnel alike were overwhelmed. The mini secretariat threatened to turn into another Singhu border for the ruling Bharatiya Janata Party.

But the same street now wears a deserted look; there aren't enough farmers to pack the tent where protest leaders sit, let alone the entire street. "Yesterday over 10,000 people ate *langar* here. But today, hardly 2,500 have come here for lunch," said Gulshan Lal, filling a glass of lassi for a policeman, just outside the Nirmal Kutiya Gurudwara.

Farmer leaders, after a string of failed talks with the administration on Wednesday, announced that the sit-in protest would continue until their demands are met. But their list of demands is shorter now - they are no longer seeking ₹25 lakh ex-gratia to kin of Sushil Kajal, the farmer who died during the crackdown on August 28; they

have also dropped demand for the immediate release of arrested protesters. What they only want now is that the M.L. Khattar government in Haryana suspend Ayush Sinha, who was sub-divisional magistrate of Karnal until recently before his transfer to Chandigarh.

Local farmer leaders on Thursday were holding their meeting in the absence of top Samyukta Kisan Morcha (SKM) leaders. "Many SKM leaders have left the protest site. We hope they will come back soon with thousands of other farmers," says Guralp Singh, a farmer from Amritsar.

According to sources, the SKM leadership wanted a quick solution to the Karnal problem, but the government refused to accept farmers' demands. "SKM leaders want-

ed high drama and 'heroic exit' on Wednesday night by courting arrest but there wasn't consensus on it," said sources. By Thursday morning, most of them silently left the spot.

The farmers fear that having more morchas will not only reduce their strength but also give a chance to the government to repeat the Bastara toll plaza incident. Around 10 farmers were injured after the police reportedly resorted to lathicharge to disperse a group of farmers near Bastara toll plaza on National Highway-44 on August 28.

Meanwhile, Haryana Home Minister Anil Vij, on demand for Sinha's suspension, said: "Nobody can be handed without a probe just because someone demands it." "The government is ready

for a probe into the entire Karnal episode," he added, stressing investigation into the role of agitating farmers.

Sinha was caught on tape allegedly telling policemen to "break heads" of farmers if they crossed the line during their demonstration last month.

By 11 am, there was a slight increase in the number of farmers coming to the protest site. In a bid to avoid further confrontation, Inspector General (Karnal Range) Mamta Singh ordered removal of all barricades. "Sab kuch khol do (open everything); nobody should say that the police have blocked the street," she said. Yet the crowd was a far cry from the gathering seen just a day ago.

Suresh Koth, member, Haryana Sanyukt Morcha, while making calls to locals to join the Karnal protest at the number at the site farmers, said: "We request farmers to come outside Karnal mini secretariat. We have to maintain our strength till the SKM's meeting on September 11," said.

Jatinder Singh Chhina, state press secretary of Kirti Kisan Union, was confident that the government will accept their demand. "They will agree. Otherwise we will sit here forever," he said.
