### IDFC fund, India SME Investments invest ₹100 cr into Citykart

PRESS TRUST OF INDIA Mumbai, January 24

**PRIVATE EQUITY FUND** IDFC Alternatives on Thursday said it along with India SME Investments has committed ₹100 crore to apparel retailer Citykart for a significant minority stake. The maiden funding for the 2016-incorporated company will help it add 100 stores in the Northern and Eastern markets and grow revenue by fourfold in the next few years, an official statement said.

The fund infusion will be done by parting a 'significant minority stake' in the company. The company has opened 40 stores on an asset light model in large retail malls across various small towns and cities in UP and Bihar during the past two years.

Its revenue has grown by an average of 32% over the last two years, the statement said without giving the absolute number.
