

CUI host webinar on scope of Start-Ups

Ranchi, (Hindusthan Samachar) : The Institution's Innovation Council of the Central University of Jharkhand recently hosted a national webinar on 'Start Up India- Scope and Applicability for Jharkhand' held under the patronship of Vice-Chancellor, CUI- Professor Kshiti Bhusan Das. DS Verma and Richa Sethi were the resource persons. Verma is the nodal officer, Start-Up Ecosystem, Department of Information Technology and E-governance, Jharkhand, while Sethi is the Program Manager for the Academy of Women Entrepreneurs.

Verma acquainted the participants with the current schemes and programs run by the government of Jharkhand and how one, with an innovative and unique idea, can be a leading start-up of the world. The process of applying to the Start Up Ecosystem in Jharkhand was explained by him in detail. He also explained about the fiscal and non-fiscal incentives one can avail, when the State Evaluation Board accepts the idea pitch. As of now, 107 start-ups have been supported and the first phase of disbursement has been done. Incubation lab of 15,000 sqft. is

Sethi informed the participants about the need of indigenous women entrepreneurs in Jharkhand. Creating women entrepreneurs, will cater to the goal of achieving the UNSDGs. She also spoke about the characteristics of an entrepreneurial mindset. She acquainted the participants with the idea 'Challenge for aspiring women entrepreneurs'.

Global certification from the University of Arizona will also be provided to the selected women entrepreneurs. This program is not only for women entrepreneurs, but men with an innovative and unique idea having a women co-founder and at least 50% of the women workforce can also apply for this. The representation of the start-up shall be done by the women. Both the resource persons exclaimed that Jharkhand is full of opportunities which have huge potential in the global market. It is a great opportunity for aspiring entrepreneurs to get mentorship and guidance through such programs.

JCO Ram Singh martyred in Rajouri

Jammu, (Hindusthan Samachar) : One Junior Commissioned Officer was martyred in the Thanamandi area of Rajouri in an encounter with terrorists yesterday. Based on specific input, a joint cordon and search operation was launched by the Indian Army and JKP on 19 Aug 2021 in village Danna, Thanamandi, District Rajouri (J&K), officials said. During the search operation in a forested area of village Danna, Thanamandi, the search party led by Junior Commissioned Officer, Subedar Ram Singh was fired upon by terrorists from a nearby densely forested area. The JCO immediately retaliated and in the ensuing firefight, one terrorist was neutralised while Subedar Ram Singh suffered a gunshot wound. The valiant JCO was provided immediate first aid and evacuated to the nearest hospital, but he succumbed to his injuries. Subedar Ram Singh, aged 46 years belonged to Village-Salana, Post Office-Bajwar, District- Pauri Garhwal, Uttarakhand. He is survived by his wife, son and daughter. Subedar Ram Singh was a brave and highly motivated soldier.

The nation will always remain indebted to him for his supreme sacrifice.

Provide jobs to unemployed dental surgeons: Rana

Jammu, (Hindusthan Samachar) : Strongly pleading the case of unemployed dental surgeons of Jammu and Kashmir, Provincial President, National Conference, Devender Singh Rana today urged the administration to come to their rescue and have the process initiated at least by filling up of the recommended 587 vacancies pending since 2018. ?The claim of the unemployed dental surgeons about their number having crossed 7000 is alarming and needs to be addressed with compassion?, Mr Rana said while interacting with a delegation of the striking J&K Dental Surgeons Association here this afternoon.

The delegation comprising of Dr Rahul Koul, President DSA, Jammu, Dr Manoj Sharma, Advisor DSA, Jammu, Dr. Vipul Misra, Vice President DSA- Jammu, Dr Arun Singh, Vice President DSA-Jammu and Dr

Robin Tikoo, General Secretary, DSA- Jammu, expressed anguish that for the past 13 years not a single post of dental surgeon has been advertised through Jammu and Kashmir Public Service Commission, National Rural Health Mission or under any other centrally sponsored scheme.

The delegation said they have relentlessly been seeking absorption of all unemployed dental surgeons through JKPS and under other centrally sponsored schemes. They have also been demanding the formulation of a policy about the recruitment of dental surgeons every year based on the number of seats in the union Territory. The association said that there was immense need for creation of a separate directorate for dentistry to ensure regulated and smooth functioning of this important discipline of medical science.
