

1. We have reviewed the accompanying statement of unaudited standalone financial results of Dhenu Buildcon Infra Limited (the "Company") for the Quarter and Nine month ended December 31, 2020 (the "Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
