## SPECIAL WINDOW - RE-LODGEMENT FOR TRANSFER OF PHYSICAL SHARES

**Background:** Securities and Exchange Board of India ("SEBI") had discontinued transfer of shares held physically from April 01, 2019. However, transfer deeds which were lodged prior to that date and rejected due to deficiency in documents, could be re-lodged before March 31, 2021.

New Opportunity: In response to feedback from investors, companies, and transfer agents, SEBI has offered a special window for re-lodgement of transfer requests for shares held in physical form. The window is open from July 07, 2025 to January 06, 2026, offering shareholders a chance to re-submit transfer deeds which were originally lodged before April 01, 2019 but were returned or rejected due to deficiencies in documentation.

Note: All shares re-lodged during this period will be processed through the transfer-cumdemat route, i.e. they will only be issued in dematerialized (demat) form after transfer.
