We wish to inform you that there has been a change in the shareholding of SBI Mutual Fund under its various schemes, in your company decreasing by 2% from the previous disclosure made by us under Regulation 29(1) of SEBI (Substantial Acquisition of Shares & Takeovers) Regulations, 2011, Vide our email dated June 23, 2020, wherein the reported holding was 4.99% (aggregating to 5%) of the paid-up share capital of your Company.

The final holding of SBI Mutual Fund, under its various schemes, as at the close of business hours on December 06, 2022 was 57,94,076 shares which is 2.8352% of the paid-up share capital of your Company.


