

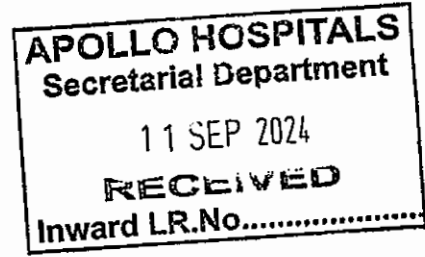
Kindly do the needful and issue new certificate of shares after transferring all the 500 shares to my name, Vaddiraju Rakesh.
