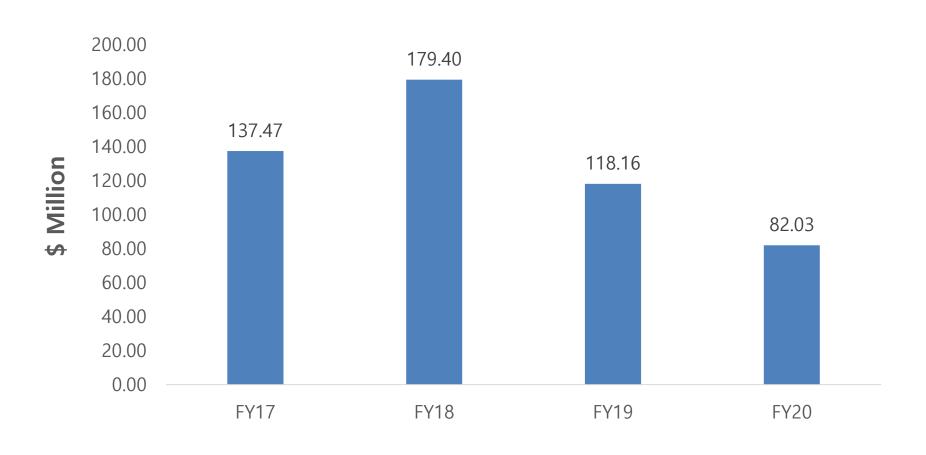

#### **E-Commerce Revenue Trend**



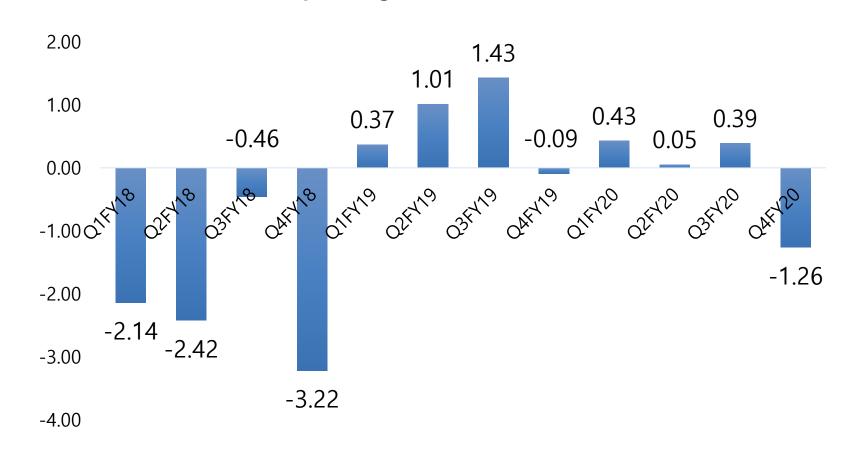
■ E-Commerce Revenue
