

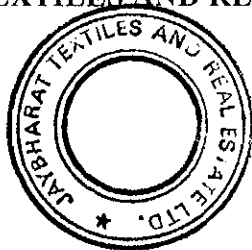

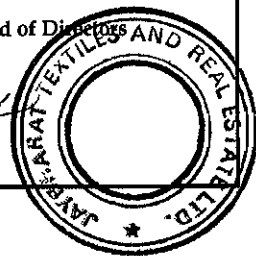
Note:-

- The Statutory Auditors of the Company have carried out a Limited Review of the standalone financial results for the Quarter and nine months ended on December 2016 in compliance with Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The standalone financial results have been reviewed and recommended by the Audit Committee and approved by the Board of Directors at its meeting held on February 10, 2017.
- The Figures of the Finance Cost has been substantially increased in Third Quarter as compared to the last Quarter, the reason being the provision for interest on the uncharged interest on loan since last 4 Years.
