**Re: Intimation regarding extension of Corporate Insolvency Resolution  
Process (CIRP) of GEI Industrial Systems Limited**

Dear Sir/Madam,

This is to inform you that the Company is undergoing Corporate Insolvency Resolution Process under the Insolvency and Bankruptcy Code, 2016 (IBC), consistent with the order passed by the National Company Law Tribunal on 20<sup>th</sup> July, 2017.

Further, the Committee of Creditors (COC) resolved to apply for extension of Corporate Insolvency Resolution Process (CIRP) and authorized Resolution Professional (RP) to file this application and the Resolution Professional (RP) had applied to the Hon'ble NCLT, Ahmedabad bench seeking extension of Corporate Insolvency Resolution Process (CIRP) for a period of 90 days beyond 180 days on the ground that resolution process could not be completed within 180 days.

Therefore, due to the reason mentioned in the application, The Hon'ble NCLT, Ahmedabad bench has ordered extension of period of corporate insolvency resolution process in respect of the Company under Section 12 of the Insolvency and Bankruptcy Code, 2016 by a further period of 90 days. Thus, the period will now end on 16.4.2018 instead of 16.1.2018 as per NCLT order dt. 20.7.2017. A copy of NCLT order dt. 10.1.2018 is attached.


